Tenderers who wish to participate in the Tendering process must register on the website <http://www.mahatenders.gov.in/nicgep/app>. Tenderers, whose registration is valid, may please ignore this step. At the time enrolment, the information required for enrolment should be filled. After enrolment the Tenderer will get his user name and password to his Mail Id.

Tenderers should have valid Class III Digital Signature Certificate (DSC) obtained from any licensed Certifying Authorities (CA). For registration, enrolment for digital signature certificates and user manual, Interested Tenderers should follow the respective links provided in Mahatenders Portal <http://www.mahatenders.gov.in>

The Tenderer can get digital signature from any one of the certifying Authorities (CA's) licensed by the Controller of Certifying Authorities namely Safes crypt, IDRBT, National Informatics Centre, TCS, Customs, MTNL GNFC and e-Mudhra.

All interested vendors, are required to be registered with BRIHANMUMBAI MUNICIPAL CORPORATION. Vendors not registered with BRIHANMUMBAI MUNICIPAL CORPORATION before can apply online by clicking the link 'Vendor Registration' under the 'e-Procurement' section of BRIHANMUMBAI MUNICIPAL CORPORATION Portal, Vendors already registered with BRIHANMUMBAI MUNICIPAL CORPORATION need to contact helpdesk to extend their vendor registration.
