RFP for Construction of 6-lane Elevated Corridor from Maduravoyal Junction (Chainage Km 13+965) - Chennai Outer Ring Road (Chainage Km 22+100) including Junction Improvements at km. 22+368 of NH-48 (Old NH-4) in Tamil Nadu on Hybrid Annuity Mode (Project Length – 8.135 kms)

The Government of India had entrusted to the Authority the development, maintenance and management of Construction of 6-lane Elevated Corridor from Maduravoyal Junction (Chainage Km 13+965) - Chennai Outer Ring Road (Chainage Km 22+100) including Junction Improvements at km. 22+368 of NH-48 (Old NH-4) in Tamil Nadu on Hybrid Annuity Mode (Project Length – 8.135 kms) (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded. Technical submissions of the Bids received online shall be opened on **10.10.2025** (at 1130 hours IST).

Bid submitted through any other mode shall not be entertained. However, Bid Security, Power of Attorney for signing of Bid, Power of Attorney for lead member of Consortium, if any, Joint Bidding Agreement for Consortium, if any, Integrity Pact, and experience certificates apostile at foreign origin, if any and other documents required as per clause 2.11.2 of RFP shall be submitted physically in original by the Lowest Bidder before issuance of Letter of Award (LOA) by the Authority. However, while submitting Bid Security via Account Payee demand draft or

Fixed Deposit Receipt or Banker's cheque, it is to be ensured by the Bidder that Account Payee demand draft or Fixed Deposit Receipt or Banker's cheque are submitted physically latest within 5-working days of the Bid Due Date (upto 11:00 hours). Please note that the Authority reserves the right to accept or reject all or any of the BIDs without assigning any reason whatsoever.
