RFP for Development of Four laning of Jagtial (Design Km. 92.700) to Mancherial (Design Km. 160.995) of NH-63 (Length 68.295 km) under NH(O) in the state of Telangana on Hybrid Annuity Mode.

The Government of India had entrusted to the Authority the development, maintenance and management of National Highway No. 63 including the section from km 92.700 to km 160.995 (approx. 68.295 km). The Authority had resolved to augment the Development of Four laning of Jagtial (Design Km. 92.700) to Mancherial (Design Km. 160.995) of NH-63 (Length 68.295 km) under NH(O) in the state of Telangana on Hybrid Annuity Mode (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded. Technical submissions of the Bids received online shall be opened on 21.11.2025 (at 1130 hours IST).

Bid submitted through any other mode shall not be entertained. However, Bid Security, Power of Attorney for signing of Bid, Power of Attorney for lead member of Consortium, if any, Joint Bidding Agreement for Consortium, if any, Integrity Pact, and experience certificates apostile at foreign origin, if any, and other documents required as per clause 2.11.2 of RFP shall be submitted physically in original by the Lowest Bidder before issuance of Letter of Award (LOA) by the Authority. However, while submitting Bid Security via Account Payee demand draft, Fixed Deposit Receipt or Banker's cheque, it is to be ensured by the Bidder that Account Payee demand draft, Fixed Deposit Receipt or Banker's cheque are submitted physically latest within 5-working



days of the Bid Due Date (upto 1100 hours IST). Please note that the Authority reserves the right to accept or reject all or any of the BIDs without assigning any reason whatsoever.
