### **RFP for Construction of new 4-lane Access Controlled Coastal Highway from Rameshwar to Konark (km.0 to km. 79.400) on Hybrid Annuity Mode in the State of Odisha (Package-I)**

The Government of India had entrusted to the Authority the development, maintenance and management of National Highway including the section from km 0 to km 79.400 (approx. 79.400 km). The Authority had resolved Construction of new 4-lane Access Controlled Coastal Highway from Rameshwar to Konark (km.0 to km. 79.400) on Hybrid Annuity Mode in the State of Odisha (Package-I) (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded. 

Bid must be submitted online only at <http://etenders.gov.in> during the validity of registration with the NHAI e-Tendering Portal being managed by National Informatic Centre (NIC), i.e. <http://etenders.gov.in> on or before 14.01.2026 (upto 11:00 hours IST). Technical submissions of the Bids received online shall be opened on 15.01.2026 (at 11:30 hours IST).

Bid submitted through any other mode shall not be entertained. However, Bid Security, Power of Attorney for signing of Bid, Power of Attorney for lead member of Consortium, if any, Joint Bidding Agreement for Consortium, if any, Integrity Pact, and experience certificates apostile at foreign origin, if any, and other documents required as per clause 2.11.2 of RFP shall be submitted physically in original by the Lowest Bidder before issuance of Letter of Award (LOA) by the Authority. However, while submitting Bid Security via Account Payee demand

draft or Banker's cheque or Fixed Deposit Receipt, it is to be ensured by the Bidder that Account Payee demand draft or Banker's cheque or Fixed Deposit Receipt are submitted physically latest within 5-working days of the Bid Due Date (upto 11:00 hours). Please note that the Authority reserves the right to accept or reject all or any of the BIDs without assigning any reason whatsoever.
