2. The bid data should be filled and the bid seals (hashes) of all the envelops and the documents which are to be uploaded by the bidders should be submitted online up to as per time schedule (Key dates).

3. The bidders shall have to submit their bids online (decrypt and encrypt the bids) and upload the relevant documents from as per time schedule (key dates).

4. Earnest money deposit on line in favor of the Commissioner Municipal Corporation Bhopal via payment gateway of E-Tendering portal.

5. The rates quoted by Bidder shall be excluding GST.

6. The envelope "C" of the qualified tender will be opened according to the key dates. Price Bid / Financial offer will not be accepted physically in any case.

7. Conditional tender shall liable to be rejected.

8. The bidder shall have to submit:

- Valid GST registration certificate.
- Valid PWD Registration Certificate.
- Valid EPF Registration Certificate.

9. Quantity of Work can be reduce / increase as per requirement.
10. Further amendment in this tender if any will not be published in any newspaper. All the amendment will be available in this portal only.
- 11. The lowest bidder shall have to submit 3% of sanction amount as performance security. Performance security submitted from each lowest bidder in the form of DD/ bank guaranty/ FDR in favour of Commissioner Municipal Corporation Bhopal**
- 12. Defect liability period is one year for this tender.**
- 13. Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid.**
