- 17) The amount of earnest money will be forfeited in case of successful bidder does not pay the amount of initial security deposit within the time limit specified as stipulated by the Executive engineer and complete the contract documents. In all other cases earnest money will be refundable.
- 18) Examination of drawing and site condition:- The Tenderer shall in his own interest carefully examine the drawing condition of contract specifications etc. He shall also inspect the site and shall acquaint himself about the climate, physical and all other conditions prevailing at site the nature, magnitude, special features, practicability of the works all existing and required means of communications and access to site, availability of housing and other facilities, the availability of labour and material, labour camp site , stores and godowns etc. He shall obtain all necessary information as to the risks, contingencies and other circumstances which may effect and influence the tender. No claims on any of the above or any factors will be entertained by the Government, should there be any discrepancy, doubt or obscurity as to the meaning of any of the tender documents, or as to the instructions to be observed by him. He shall set forth in writing such discrepancy or doubt of obscurity and submit the same to the Executive Engineer.

19) The tender submitted by the tenderer shall remain valid for period of 90 days from the date opening of tenders. Also see para 2 General Rules etc. of contract form.

20) The contractor (s) whose tender is accepted is required to note that no foreign exchange will be released by the Department.

21) Tenders, which do not fulfill all or any of the conditions or are incomplete in any respect are liable to summary rejection.

23) This notice inviting tender shall form part of the tender agreement.

24) The successful tenderers will be required to produce to the satisfaction of the specified concerned authority a valid and concurrent licence issued in his favour under the provisions of the Contract Labour (Regular and Abolition) Act, 1970 before starting the work. Failure to do so, acceptance of the tender shall be liable to be withdrawn and security deposits forfeited.

25) Right is reserved to revise or amend the contract documents fully or part thereof prior to the date notified or amended for the receipt of tender, such deviations, amendment if any, shall be communicated in the form of corrigendum or by a letter as may be considered suitable. 26) Tenderers shall fill in, the percentage above or below figure, on the space provided in the BOQ and upload it along with the required documents.

27) Right to reject or cancel any or all the tenders without assigning any reasons thereof whatever may be is reserved by the undersigned.

28) Time allowed for completion of each work is shown in above Table and defect liability period shall be 12 months from the date of completion of work.

29) Additional Performance Securities

After opening of financial Bid (Envelope No. 2) if quoted offer of the lowest tenderer (L-1) is found below the estimated cost of the department then, L-1 tenderer should deposit submit the required "Additional Performance Security" within period of eight days from the date of opening of financial Bid (Envelope No. 2). If L-1 tenderer should not submit Additional Performance Security as stated above, then his offer will be considered as "Non-Responsive" and Second lowest's (L-2) tenderer will be called for negotiations. If such L-2 is agreed to execute the work below than the

A) If L-1 tenderer's offer is below more than 1 % to 10 % of the estimated cost put to tender then he should submit Demand Draft amounting to 1% of the estimated cost of the department towards Additional Performance security.

B) If L-1 tenderer's offer is more than 10 % below upto 15% of the estimated cost put to tender then he should submit Additional Performance security of 1 % for every percent after 10 % below percentage in addition to the cost of 1% performance security mentioned above clause A for quoting below offer.

(eg. If L-1 tenderer's offer is 15 % below the estimated cost put to tender, then he should submit 15-10 = 5 % Additional Performance security + 1% Additional Performance security = 6 % amount of amount of the cost put to tender as a total Additional Performance Security.)

C) If L-1 tenderer's offer is more than 15 % below the estimated cost put to tender then he should submit Additional Performance security 2 % for every percent after 15 % below percentage in addition to the cost of 6% Additional performance security mentioned above clause A & B.

(eg. If L-1 tenderer's offer is 19 % below the estimated cost put to tender, then he should submit [1% for below upto 10% plus 5% for below upto 15 % & two times for remaining percentage i.e. (19-15) 4 % X 2=8 %] Total (1+6+8 =) 14 % amount of the cost put to tender as Additional Performance Security.)

1) Such Demand Draft shall strictly issue only by the Nationalized Bank or Scheduled Bank in favour of **Sarpanch / Sachiv G.P. Wathoda Khurd, Tq. Tiwsa** and shall be valid for the minimum period of three months

2) The Demand Draft should be the MICR and IFSC Code Number of the issuing bank.

The tenderer shall write the 'Name of Work,' 'E- Tender No.' and 'Tender Notice No.' on such sealed envelope addressed to the concerned **Sarpanch / Sachiv G.P. Wathoda Khurd, Tq. Tiwsa**

4) If it is found that the Demand Draft as above submitted by the tenderer is False / Forged Or Tenderer treated as "Non Responsive" then the Earnest Money submitted by such tenderer shall be forfeited and

his Bid (Tender) as a contractor will be Canceled. For this concerned **Sarpanch / Sachiv G.P. Wathoda Khurd, Tq. Tiwsa** shall have the full rights.

5) The work order to the successful contractor shall be issued only after the encashment of his Demand Draft by the concerned **Sarpanch / Sachiv G.P. Wathoda Khurd, Tq. Tiwsa**

6) The amount of Additional performance security of successful contractor shall be refunded within the period of three months after the date of completion of said work successfully

30) Clause for Royalty / Laboratory Testing Charges.

ii) Contractor will be paid separately for the testing of materials in P.W.D./ P.M.G.S.Y. Laboratory as per current testing charges, on production of satisfactory test results. Any short fall in the testing, as per frequency, will be recovered at three times testing rates.
