Manual bids shall not be accepted.

AIIMS, Patna request bidders to quote online with tender documents uploaded & submit the offer on our e-portal <https://eprocure.gov.in/eprocure/app>.

**Upload of Tender:** Tenderers are advised to download Notice Inviting Tender along with other tender documents and submit the declarations and tender documents along with clear scanned copies of requisite documents to substantiate the claim towards their credentials while the tender shall be submitted online in soft copy on our e-tendering portal.

All interested bidders have to submit techno commercial bid (Part I) & Price Bid (BOQ) (Part II) strictly in the tender format available online on e-portal. No other form of bid shall be accepted. Bids shall be digitally signed and uploaded by legally authorized and competent person on behalf of his firm / company and relevant documents w.r.t. the same to be uploaded along with the bid by the bidders.

Earnest Money Deposit has to be submitted as per NIT /Tender instructions before the due date and time of tender techno commercial bid opening , failing which the bid shall be liable for rejection.

## 5. Bid Submission:

Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>. Tenderer/Contractor are advised to follow the instructions provided for online submission of bids. Bid documents may be scanned with black and white option which helps in reducing size of the scanned document.

- 5.1 Not more than one tender shall be submitted by one contractor or contractors having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
- 5.2 Tenderer who has downloaded the tender from the **website of AIIMS, Patna** [www.aiimspatna.org](http://www.aiimspatna.org) and **Central Public Procurement Portal** <https://eprocure.gov.in/eprocure/app> shall not tamper/modify the tender form including downloaded price, bid template in any manner. In case, if the same is found to be tampered/modified in any manner, tender will be completely rejected and EMD would be forfeited. The tenderer is also liable to be banned from doing business with AIIMS Patna.
- 5.3 Intending tenderers are advised to visit **AIIMS, Patna** web site [www.aiimspatna.org](http://www.aiimspatna.org) and CPPP website <https://eprocure.gov.in/eprocure/app> regularly till closing date of submission of tender for any corrigendum / addendum/ amendment.

- 5.4 Applicant contractor/vendors/bidders must provide Tender fee/Cost & EMD Payment: Tender Fee/Cost & Earnest Money Deposit is to be **deposited electronically by RTGS/NEFT in the account of AIIMS Patna** at the below mentioned details.

**5.6** Estimated Cost **(For Rs. 25,44,380/-) (Rupees Twenty Five lakh Forty Four thousand Three hundred Eighty only)** Period of Bid Validity Days: -270 Days from the date of bid opening.

**5.7** Duration for Completion of **Aluminium partition, electrical and Air conditioning work in different area of Obstetrics and gynaecology department of AIIMS Patna. is 90 Days.**

**5.8** **Tender fee and EMD both has to be submitted by the bidder, No exemption allowed.**

**5.9** Bids will be opened as per date/time as mentioned in the Tender Critical Date Sheet. After online opening of Technical-Bid the results of their qualification as well Price-Bid opening date will be intimated in due course.

**5.10** AIIMS Patna reserves the right to reject any or all tenders and shall not be bound to assign the any reason for such rejection.

**6. Submission of Tender**

The tender shall be digitally uploaded using their DSC in two part, viz., technical bid and Price bid.

All the pages of bid being submitted must be signed and sequentially numbered by the bidder irrespective of nature of content of the documents before uploading.

The offers submitted by Telegram/Fax/email shall not be considered. No correspondence will be entertained in this matter.

**Technical Bid**

The following documents are to be furnished by the Contractor along with Technical Bid as per the tender document:

- I. Signed and scanned copy of proof for payment of Tender fee & Earnest Money Deposit (EMD), No exemption allowed.
- II. Signed and scanned copy of PAN and valid electrical License.
- III. Signed and scanned copy of GST registration certificate, with up to date clearance certificate.
- IV. Signed and scanned copy of Letter of Transmittal as per format attached in tender document
- V. Signed and scanned copy of structure organization of bidder as per “form A”
- VI. Signed and scanned copy of Certificate for sole ownership / partnership/ Certificate of Incorporation.

- VII. Signed and scanned copy of Statements of turnover per year for last three successive years duly certified by the Chartered Accountants with UDIN no. (Average Annual Turnover must be **at least 50% of estimated cost** As per “form B” (with supporting documents).”
- VIII. Signed and scanned copy of Tender Acceptance letter “as per format attached in tender document”.
- IX. Signed and Scanned copy of Banker’s Certificate, issued by a Scheduled Bank . The certificate should have been issued within 6 month form original last date of submission of tender as per “ Form C”
- X. Signed and scanned copy of proof of Status of Bidder: Bidder should have registration with Govt. / Semi Govt. organization like railways, CPWD, BRO, MES, State PWD whose jurisdiction defined to work in Bihar state in appropriate class are eligible to participate in tender and having experience in similar work.
- XI. Signed and scanned copy of satisfactorily completed the similar works during the last five (5) years prior to the last stipulated date for submission of the bid as per “Form D” (with supporting documents)
- XII. Signed and scanned copy of Power of Attorney as per “Annexure – II” in favour of person.
- XIII. Signed and Scanned Copy of affidavit duly certified by the notary at the location of the Agencies/Headquarters that the bidder has never been black listed or punished by any court for any criminal offence/breach of contract and that no police/vigilance enquiry/criminal case is pending against either bidder legal entity or against individual Directors of the company or partners etc. of the firm etc.
- XIV. Signed and scanned copy of Audit report and ITR of last Three years ending 31st March 2025 duly certified by the Chartered Accountant, company should be financially sound and have suffered no loss till 31/03/2025.
