

Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of Receiving / Opening of Bids as specified, the bids will be Received / Opened on the next working day at the same time and venue.

7. Balance Bid security @ 1% of contract value shall be furnished duly pledged in favour of the Superintending Engineer, Division No.III, BDA, Bhubaneswar at the time of execution of agreement
8. If the office happens to be closed on the stipulated date of closing / opening of bids as specified, the bids will be closed / opened on the next working day at the same time and venue.
9. The criteria governing as per DTCN will be considered for qualification of covers.
10. Other details can be seen in the bidding documents.
