**NOTICE FOR INVITATION OF E-TENDERS (NIT)**

On behalf of Chairman, U.P. Jal Nigam, C.&D.S., (E/M.WING), U. P. Jal Nigam (Urban) invites percentage rate e-tenders on a two bid system from eligible contractors/ firms. Bidders are advised to carefully note the eligibility/ qualification requirements prescribed for the bid. They should submit their bids only if they consider themselves eligible and are in possession of all the requisite documents.

2. The Bid submission start date shall be 12.05.2026
3. The Bid should be valid for 120 days from the last date of submission of bids. Bid once submitted, cannot be withdrawn.
4. If the date of opening of technical bid happens to be a holiday, the bid shall be opened on the next working day at the same time for which no separate communication shall be sent.
5. Bidders having criminal record will not be allowed to participate in Bid process. And if it is found during the tendering processes then the bidder will be debarred /disqualified from the process.
6. A person or his/her firm registered with any State Bar Council/National Bar Council will not be eligible to participate in the Bid.
7. Contractors who inter-alia full fill the following requirements shall be eligible to apply (As per M.D., U.P. J.N. (Urban) order No 507/1009/072-001/Nivida/PPRBD/23 Dated 28-09-2023.
  - (a) Firm should have successfully completed and commissioned, **similar works** during last Ten Years -ending PREVIOUS DAY of the last date of bid submission on which application are invited satisfying either of following conditions.
    - a. Three satisfactory completed tested and commissioned work. similar works each costing not less than the amount equal to 30 % of estimated cost put to tender

b. Two satisfactory completed tested and commissioned work. similar works each costing not less than the amount equal to 40 % of estimated cost put to tender

or

c. One satisfactory completed work costing not less than (60%) of cost of work put to bid.

**Experience of Central/State Govt. Organization/Central Autonomous Body/Central/ State Public Sector undertaking/Nigam will only be considered.**

**Similar works shall mean SITC of High Mast Light work.**

(B).Should have average annual financial turnover during the immediate last 3 consecutive financial years on construction work should be at least 30% of the project cost put to tender.

(C). Net worth of the bidder should be positive on date of bidding.

(D). Should have a solvency of 40% of the tender value will be required to be submitted.

or

Solvency Certificate issued by any schedule commercial bank shall be accepted, which will be valid for a period of One Year from the date of issue unless otherwise mentioned.

or

Solvency certificate issued by District Magistrate will also be accepted which will have a validity of one year from the date of issue unless otherwise mentioned.

8. The payment will be made as per availability of funds from client department. No claim will be entertain due to unavailability of funds.
9. This NIT and other Information/ corrigendum and Instruction for bidders posted on website shall form part of bid document.
10. The quantities given in the Bill Quantities are estimated and provisional, and are given to provide a common basis for bidding. These are liable to change upto any extent for which no claim shall be admitted whatsoever.
11. The bid document consisting of Technical (eligibility) bid & financial bids including specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary document are available on "<https://e-tender.up.nic.in>".
12. The technical bid shall be opened first on due date and time as mentioned above. The time and date of opening of financial bid of contractors, qualifying the technical bid shall be communicated to them at a later date.
13. If the Bidder feels that technical credentials of his own or other Bidders have been wrongly evaluated/verified, **he may raise objection within 2 (two) working days from the date of uploading of result.** Opening of financial bid will be scheduled accordingly. No requests/objections shall be entertained beyond above limit; else it may be treated as an obstruction in tender process and shall be dealt with accordingly.
14. The department reserves the right to reject any prospective application or to cancel entire bid process without assigning any reason whatsoever.
15. The competent authority on behalf of Chairman, U.P. Jal Nigam reserves the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
16. In compliance to GO. No. 01/2018/3070/78-2-018/42 I.T/2017/(22) dated 03.01.2018 , the bidder has to **mandatorily deposit, from his own resources, Tender Fees (non-refundable) & Earnest Money separately through the mechanism of RTGS/NEFT as per following details:-**

**The Bidder shall deposit tender fees and earnest money separately in account mentioned as above and quote UTR NO., Date and amount of deposit in the capability statement available on portal. Further he shall upload digitally signed copy of original receipts of bank showing clearly the above details. IT is made clear that Tender Fees and Earnest Money Deposited in any other form and account shall render the bid non- responsive.**

The bidder will, in addition to other documents, upload scanned and digitally signed copies of original proof of cost of bid document i.e., Tender Fees, Earnest money deposit as described above, Solvency Certificate and Standard Affidavit in prescribed form 'I-C'.

17. All the documents as specified in the technical bid/eligibility bid document should be uploaded within the period of bid submission. The department will not be liable for incomplete/inaccurate/non-submission of bid for any reason whatsoever including technical reasons. **It is made clear that separate submission of originals of any documents, other than scanning and uploading them, are not required unless called for after opening of financial bid.**
18. The bid submission shall become invalid if:
  - (i) The bidder is found ineligible.
  - (ii) The bidder does not upload all the documents, including GST registration, as stipulated in the bid document.
  - (iii) If any discrepancy is noticed between uploaded documents and originals/hard copies submitted later.
  - (iv) If subsequent to due date of submission of bid and after its submission bidder makes any further communication / representation with the department with regard to the bid (whether technical of financial) than otherwise called for by the undersigned as a clarification.
19. The Bidder shall have to submit additional security/performance security with acceptance of Bid in compliance to M.D, UPJN, Order No. 507/1009/072-0001/Nivida/PPRBD/23 dated 28.09.2023, if the financial bid is found to be below norms as specified.
20. Canvassing whether directly or indirectly, in connection with bids is strictly prohibited and the bids submitted by the bidders who resort to canvassing will be liable for rejection & will be debarred from future tender in C.&D.S. (E/M.WING), U P Jal Nigam (Urban).
21. The bidder shall not be permitted to bid for works under supervisory control of Project Manager concerned who is responsible for execution of work, in which his near relative is posted. He shall also intimate the names of persons who are working with him in any capacity or; are subsequently employed by him and who are near relatives to any officer in the C.&D.S. (E/M.WING), Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of C.&D.S. (E/M.WING), and make him liable for black listing.
22. No Engineer or other Gazette Officer employed in Engineering or Administrative duties in an Engineering Department of the STATE GOVERNMENT/State department Undertaking is allowed to work as a contractor for a period of two year after his retirement from Government service, without the prior permission of the Government of U.P. in writing. This contract is liable

to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of U.P. as aforesaid before submission of the bid or engagement in the contractor's service.

23. Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the means of access to the form and other circumstance which may influence or affect their bid. A bidders shall be deemed to have full knowledge of the site whether he inspect it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidders shall be responsible for arranging and maintaining at his own cost all materials, tools and plans, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for on the contract documents. Submission of a bid by bidders implied that he has read this notice and all other contract document and has made himself aware of the scope and specifications of the works to be done local conditions and other factors having a bearing on the execution of the work.
24. In case of contradiction condition prevailing in NIT will be final.
25. For any dispute Jurisdiction area will be Lucknow District only.
26. Quantity may be increased or decreased as per requirement of Client department or as per site conditions.
27. The department will not be responsible for any technical issue of the e-procurement portal.
28. Contractor will be responsible for all required N.O.C. from relevant department before/after work execution as per rule/requirement and it is mandatory. If any penalty imposed that will be paid by the firm. The bidder shall be responsible for handing over of above works to relevant department. The Bidder should give an affidavit on Rs. 100/- non judicial stamp paper for that. Without submission of the Affidavit the bidder will not be Qualify in bidding process.
29. The Bidder are advised to quote their rates in percentage basis below and above against Schedule e-procurement portal.
