Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to Bidders to qualify for the award of the contract.**

- 3 The bids shall remain valid for acceptance for a period of **Three Months** from the last date of submission of bids. Bids once submitted cannot be withdrawn.
- 4 Bids must be accompanied by non-refundable fee as indicated in Column 6 of the above table, in the form of Demand Draft of any Schedule bank, for amount indicated in favor of "**Executive Engineer, Provincial Division, P.W.D., Pilibhit**" payable at **Pilibhit**. A set of bidding documents will be available online on website <http://etender.up.nic.in>
- 5 Bids can be downloaded online from date **15.04.2026 to 21.04.2026 at 12:00 Noon** and bid can be submitted online on or before **21.04.2026 at 12:00 Noon**. The technical bids will be opened online on date **21.04.2026 at 12.30 PM**. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened online on the next working day, respectively, at the same time and validity of bid will be considered from the original date. The date and time of opening of the financial bid shall be notified on website. The Financial bids shall be accordingly opened online.
- 6 A pre-bid meeting will be held for each work **16.04.2026 at 12.00 Noon** at **OFFICE OF Executive Engineer P.D., P.W.D. Pilibhit** corresponding to the respective package to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of 'Instructions to Bidders' of the bidding document..
- 7 Bids must be accompanied with security of the amount specified for the work in the table-5. Bid security will have to be in any one of the forms as specified in the bidding document and shall be valid for 45 days beyond the validity of the bid. Bid security pledged in favour of "**Executive Engineer P.D., P.W.D. Pilibhit**."
- 8 A bidder shall not be permitted to bid for works in the Circle responsible for award and execution of contracts in which his or his spouse's near relatives (defined as first blood relations, and their spouses) is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive).
- 9 No Engineer of Gazette rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State / Central Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without Government permission. This contract is liable to be cancelled if either the Contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the Contractor's service.

- 0 Bid documents and other details consisting of qualification information and eligibility criterion of bidders, plans, specifications, drawings, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the Contractor can be seen in the office of the Executive Engineer mentioned in column 7 of the table corresponding to the respective package between hours of 11.00 am and 04.00 pm on any working day between **15.04.2026 to 20.04.2026**
- 11 Any bidder who is having criminal record is not allowed to participate in the bidding process.
- 12 Any bidder who is registered with the state Bar Council is not allowed to participate in the bidding process.
- 13 Each bidder is required to furnish an affidavit online on a non-judicial stamp paper of Rs. 100/-giving all information on prescribed Performa required for evaluation of the bidding capacity of the bidder.
- 14 Bidder must submit information/document on prescribed Performa ie. T4, T5, T6 with each bid.
- 15 Compliance as per G.O. No. 1/2018/3070/78-2-2018/421.T./2017(22), Dt. 03-01-2018 and G.O. No. 36/23-8-2018-176(Gen.)2006T.C.-1 Dt. 12-01-2018 is strictly to be complied by the bidders.
- 16 The Contractor has to make sufficient arrangements during construction to pass the traffic without any obstruction.
- 17 Contractor shall have to provide an undertaking for required capacity of T&P within distance from the work site prior to start of the work.
- 18 If any defect is found in the work, the loss shall be recovered from the contractor as per current prevailing rules
- 19 As per G.O. 622/23 -12-2012-2 Audit /08 T.C. dated 08.06.12 the Bidder shall be deposited extra security money for his below tender rates @ for up to 10% below @ 0.5% of each percentage and for more than 10% below rate @ 1% of each percentage. As Par GO No. 622/23-12-2012-2Audit/08 TC-02 L.N. Anubhag-12 dt 08-06-2012 and 692/23-07-2024 dt-09-08-2024.
- 20 Contractor shall abide by the rules & orders issued from the department / U.P. Government during the pendency of contract Bond.
- 21 Tender Inviting Authority will have the right to reject one or all bids without assigning any reason to the bidders.
- 22 In case of any dispute regarding tender, the Judicial Jurisdiction of the honble District court Pilibhit will be acceptable.
- 23 Bidder has to provide extra performance security at the of making bond of percentage below bid in compliance of G.O. 622/23-12-2012-2 AUDIT/08 TC-2 Dated 08-06-12 and 692/23-07-2024 dt-09-08-2024 as per rule as below.
- A. Up to 10 percent below rates on BOQ at the rate 0.50% per 1% rate.
- B. In case of bidders quote the rate more than 10% below on BOQ then bidder has to provide extra performance security at the of 1% per below rate.
- 24 Undersigned on behalf of the Governor of Uttar Pradesh will have the right to reject one or all bids without assigning any reason to the bidders.
