No other form of bid security will be accepted.
- Tender Fee:-** As per coloum 7 (non-refundable) To be deposited in the account of UP e-tender online Account through e-tender portal by Internet Banking only. All concerned please note that the bidding process will not move onward if the the bid document's Cost (Tender Fee) is not paid through e-tender portal by Internet Banking.

The technical bids will be opened online on Date **28.04.2026** at 12:30 PM. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened online on the next working day, respectively, at the same time and validity of bid will be considered from the original date. The date and time of opening of the financial bid shall be notified on website. The Financial bids shall be accordingly opened online.
- A pre-bid meeting shall be held in the Office of the Superintending Engineer, Bareilly Circle, U.P.P.W.D. Bareilly for above work on Dated **23.04.2026** at 12.00 Noon corresponding to the respective package to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of 'Instructions to Bidders' of the bidding document.
- A bidder shall not be permitted to bid for works in the Circle responsible for award and execution of contracts in which his or his spouse's near relatives (defined as first blood relations, and their spouses) is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive).
- No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State/Central Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without Government permission. This contract is liable to be cancelled if either the Contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the Contractor's service.
- Bid documents and other details consisting of qualification information and eligibility criterion of bidders, plans, specifications, drawings, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the Contractor can be seen in the office of the Executive Engineer

- corresponding to the respective package between hours of 11.00 am and 04.00 pm on any working day between 21.04.2026 to 27.04.2026.
12. Any bidder who is having criminal record is not allowed to participate in the bidding process.
 13. Any bidder who is registered with the state Bar Council is not allowed to participate in the bidding process.
 14. Bidder must submit information/document on prescribed Performa i.e., T4, T5(Attested Photo copy) and T6 in original with each bid.
 15. According to the provisions of Government Order no. 3070/78-2-2018/42 IT/2017 (22) Date 03-01-2018 after opening of the technical and financial bids, the bidder has to submit original documents personally in department/ office. In the event of non submission of original documents by the bidder, the appropriate action will be taken in accordance with the provisions of G.O.
 16. All bidders must have labor registration in labor welfare department.
 17. 1% Labor cess will be deducted from the Contractor Bill as per rules.
 18. The Contractor make sufficient arrangement during construction to pass the traffic without any obstruction.
 19. If any defect is found in the work the loss shall be recovered from the contractor.
 20. Defect Liability period shall be as per G.O.No.17/2024/(Gen.)-113/23/23-1-2024-23-1099/113/2023 date 16.01.2024 and HOD letter 233 कैम्प-प्र0अ0विकास/03(मु0-1)/2024दिनांक 24.12.2024 (If its Applicable)
 21. G.O. No. 8/2017/836/23-7-17-176(Gen.)/06 date 08.06.17 shall be effective.
 22. Bidder has to provide additional performance security at the of making bond of percentage below bid in compliance of G.O. 692/23-7-2024 Dated 09-08-2024 as per rule as below.
 - (A) Up to 10 percent below rates on BOQ at the rate 0.00% per 0% rate.
 - (B) In case of bidders quote the rate more than 10% below on BOQ then bidder has to provide extra performance security at the of 1% per below rate.

 28. In PWD technical evaluation of tender is to be done by Prahari Software. URL for Prahari is <http://wms.uppwd.gov.in/Prahari/>. One Opening of the website Prahari login page will open in which user type Contractor is to be selected. Use name and Password for login on Prahari shall be same as used for contractor's registration on Chanakya Portal. Bidders have to be upload all the basic information and required document on Prahari as given in Prahari in detail. A bidder will be responsible for that.
 29. After uploading all the information & document on Prahari bidder shall have to download technical sheet E1 after submitting. Scan copy of technical sheet E1 shall be uploaded on E-tender portal <http://etender.up.nic.in> by the bidder. Bidder shall not upload any document other than technical sheet E1 on E-tender portal. If the bidder is uploading any document other than technical sheet E1 on e-tender portal, the document uploaded on e-tender portal shall not be considered for technical and claim of contractor in this regard shall not be entertained.
 30. Bidder are expected to upload all the information and documents well before submission date and time to avoid problem caused by slow internet speed/server problem related to Prahari any claim of contractor in this regard shall not be entertained after wards.
 31. Some information/documents to be uploaded by bidders on Prahari have to be approved by the department for final submission. Bidders are advised to contact any Division/ Circle of department after uploading on Prahari such information/documents with original documents and ensure is approval from the authority of the department.
 32. Contractor shall abide by the rules & orders issued from the department/U.P. Government during the pendency of contract Bond.
