The Superintending Engineer, M.I. Division, Kalahandi, District-Kalahandi on behalf of Governor of Odisha invites Percentage Rate Bids in **Single Cover** System through e-procurement to be received in online mode only for the works as detailed in the table below. 1. Further details can be seen from the “e” Procurement Portal <https://tendersorissa.gov.in>
2. Bidding documents can only be available on-line in the Government of Odisha website <http://tendersodisha.gov.in> from 11:00 AM on 08.05.2026 and up to 5:30 PM on 18.05.2026 for preview, download & submission.
3. The intending bidders should visit the work site before tendering and should be prepared with required machineries for earth work and concrete work to complete the work by the scheduled period of completion.
4. The Bidders desiring to participate in “On-line” bidding must possess compatible **Digital Signature Certificate of Class-II or Class-III**. The web site for the on-line bidding is <http://tendersodisha.gov.in>.
5. Tender shall be uploaded in standard formats prescribed in the bid documents displayed at Govt. of Odisha e-market place web site & submitted duly filled up. The bidders should upload on-line the **scanned clear copy** of the **affidavit** in support of correctness or proof of the information submitted including bid security accompanied with tender by them. They should **digitally sign** on all statements, documents, certificates uploaded by them, owning responsibility for their correctness/ authenticity. If the documents are not digitally signed, an **affidavit** owing genuineness of the documents should be uploaded. The affidavit of authenticity of documents uploaded by the bidder being a legal document, checking genuinely of signature put on other uploaded documents including affidavit and lease deeds is beyond preview of the officer inviting tender. The bidder himself is liable for the authenticity of the documents if challenged by any other bidder or in the court of law.
6. The bid documents should be uploaded by the bidder accompanying copies of **Registration, GST Certificate, PAN Card, Cost of tender papers, Affidavit about authenticity of documents, Affidavit about current litigation & Debarring and No Relation Certificate in Prescribed proforma** provided in DTCN else the bid will liable for rejection.
7. **The bidder shall have to furnish present address along with Pin code, Active Mobile No. & Email Id in separate sheet** along with the tender documents for official correspondence, if any. No paper correspondence shall be made in this regard to avoid delay in finalization of tender. In case of lottery need to be conducted in accordance with the Works Department Memorandum No.632 dated 09.01.2026, intimation will be given through mail/mobile number. **(This office will not be held responsible for non-intimation of mobile no/ e-mail id of bidder along with tender documents)**
8. The cost of tender paper as tabulated in the annexure shall be received **online** along with the bids as per guideline issued by Works Dept O.M No 6785 dated 09.05.2017 and No 17254 dated 05.12.2017. The procedure of bid submission using electronic payment of tender paper cost by the bidder may be referred in Works Dept O.M No 17254 dated 05.12.2017 which has been added to the DTCN.
9. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid Security (Col-4) instead of 1%. **The bidders shall have to furnish 1 % of tender amount towards Bid Security as EMD on Online failing which the tender will be rejected.** Further, wherever, there are compelling circumstances to ask for Bid Security, the same should be done only with the approval of the next higher authority to the authority competent to finalize the tender. If they withdraw or modify their bids during period of validity etc., they will be suspended for the time specific in the tender documents.
10. One bidder can submit only one tender paper for each of the works for which tender invited in this notice in his

own DSC. Submission of more than one tender paper for any particular of work by a bidder through different DSC or through his own DSC for a particular tender will be liable for rejection of all such tenders.

11. Scanned clear copies should be uploaded. Non-visible copies of Documents may be liable for rejection.
12. **Engineering Contractors willing to avail exemption of EMD shall furnish an affidavit to the effect that he has not availed the benefit for more than two times during this financial year and original license shall be submitted before the authority for making necessary entry in the original license, if successful & selected for awarding the work as per Letter No FA-Codes-6/2011- 600 dated 18.1.2011 of Works Department.**
13. The SC/ST contractors seeking exemption of 50% EMD or 10% price preference required to produce an affidavit to this effect. The ST/SC contractors having Degree/ Diploma in Engineering are not allowed to avail both the benefits. Both Engineering and ST/SC contractors should submit the affidavit in writing regarding the facility to concerned officer inviting tender, otherwise they will not entitle to get the facility.
14. The successful bidders will have to deposit remaining bid security @ 1%. i.e. ISD (Initial Security Deposit) of the agreement value in the form of Term Deposit receipt of any Nationalized bank duly pledged in favour of the Superintending Engineer, Minor Irrigation Division, Kalahandi, Bhawanipatna and payable at Bhawanipatna as per the terms & conditions laid down in OGFR and in no other form during execution of the agreement.  
**N.B.** a) No Cheque / Bank draft / Cash Payment will be accepted.  
b) Adjustment of earnest money given with other tenders previously and submitted with other tenders shall not to be entertained.
15. The contractor should have registered his/her name in Contractors Database Management System (CDMS) irrespective of tender amount in concurrence to Letter No.30613, dt.22.07.2019 of Engineer-in-Chief (Civil), Odisha, Bhubaneswar. Non-registration in CDMS portal is liable for rejection of the tender.
16. **After careful observation, Government has been pleased to abolish the extant provisions of threshold negative bid caps of 15% introduced** vide Works Department OM No. 12366/W dt. 08.11.2013 and amended vide Works Department OM No. 1437 dt, 31.01.2023 in Appendix-IX, Clause 36 of OPWD Code Volume-II in the procurement of works undertaken by the Govt of Odisha and its agencies to ensure the procurement process results in a viable and successful manner with adoption of following incremental Additional Performance Security (APS) system.
17. **Additional Performance Security (APS) shall be obtained from the Successful Bidder when the Bid amount is less than the estimated cost put to tender shall have to furnished the Additional Performance Security as per the guide line issued by Works Department Office Memorandum No 173 dated 03.01. 2026. Additional performance Security in shape of N.S.C/Postal Saving Bank Pass Book/K.V.P/ Post Office Term deposit receipt / Deposit receipt of any Nationalized /Schedule Bank duly pledged in favour of the Superintending Engineer, M.I. Division, Kalahandi within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-Mail/Whatsapp ) otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/ Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder.**

The State Government has been pleased to fix the following rate of Additional Performance Security as below

2	Where the bid price is below 10% but not below 20% of the project cost put to bid	The additional performance guarantee/security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid, starting at 11%, with the additional bid performance guarantee being 0.1%, and this additional performance guarantee percentage shall be applied on the bid price.
3	Where the bid price is 20% or more below of the project cost put to bid	The additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price.

18. Justification for abnormally low bids shall be scrutinized by the Departmental Technical Committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security (APS). An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other requirements of the bid document., If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/ Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.
19. **If more than one bid is quoted (decimal up to two numbers will be taken for all practical purposes), either at the estimated cost put to tender or less than the estimated cost put to tender,** the tender accepting authority will finalize the tender through a transparent lottery system, where all the concerned bidders/ their authorized representatives, the concerned Superintending Engineer and the Divisional Accountant Officer (DAO) will remain present as per Works Department Memorandum No.632 dated 09.01.2026
20. If the rate quoted by the SC and ST Category Contractors comes to the rate quoted by the L1 bidder (decimal up to two numbers will be taken for all practical purposes) after availing 10% price preference as per Para 2 of Works Department Resolution No. 27748 dated. 11.10.1977, the tender shall be finalized by the tender accepting authority through a transparent lottery system along with other categories of contractors.
21. The tender/tenders, where all technical qualified bidders for each package have quoted same rate at par with schedule of rates will be cancelled without any transparent lottery system as per Letter no. 7787 dated 31.05.2021 of Govt. of Odisha Works Department.
22. **Agreement shall be drawn only after due verification of EMD & APS of the successful bidder. Submission of fake NSC/ Post office savings Bank account/ Post office Time Deposit Account/ Kisan Vikas Patra/ Bank**




**Guarantee shall lead to rejection of Bids and criminal action shall be initiated against the concerned bidders.**

23. The bidder shall have to furnish **No relation certificate as on schedule - A in DTCN.**
24. The bidder shall have to furnish the information regarding current **litigation, debarring, expelling of tendered or abandonment of work by the tenderer as per schedule "B" in DTCN.**
25. The bidder shall have to furnish **Affidavit about authenticity of documents in proper format as on schedule "C" in DTCN.**
26. If L1 bidder does not turn up for agreement after finalization of tender, then he shall be debarred in participating in bidding for three years and action will be taken to blacklist the contractor. In that case the L2 bidder if fulfils all other criteria would be called for drawing agreement for execution of work subject to the condition that L2 bidder negotiates at par with the rate quoted by the L1 bidder, otherwise tender will be cancelled.
27. Time is the essence of the contract; no Extension of Time will be allowed as it is a non-plan scheme. Penalty will be imposed as per Agreement Conditions if the work is not completed within the stipulated period / not in proportion to the work programme.
28. **The estimated cost put to tender is exclusive of GST as applicable.** GST on work contract as applicable at the time of payment shall be paid extra over the gross amount of running bill amount (vide section 15 & section 162 (ii) of Odisha Goods & Service tax Act 2017.
29. **Payment will be made as per the availability of Funds.**
30. The Tender will be opened on the next working day if the date of opening happens to be holiday.
31. The bidder or agent authorized by him/her should remain present at the time of opening the technical bid
32. The amount quoted by bidders shall remain **valid for 90 (ninety) days** from the date of opening of financial bid. If any bidder backs out from the bidding process, or make any request for alteration or modification in terms & conditions of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including recommendation to registering authority for cancellation of his/her registration as contractor including forfeiture of bid security deposited.
33. If any intending bidders wish to withdraw from participation in the bid, He/ She can freely withdraw from the participation before scheduled date and time of closure, in case the 1st lowest bidder or even the next lowest bidder withdraw in series one by one, in later stage thereby facilitating a particular bidder for award, then they shall be penalized with adequate disincentives with forfeiture of EMD / Bid security unless adequate justification for such back out is furnished. Appropriate action for blacklisting the bidder shall also be taken apart from disincentivizing the bidder.
34. The Authority will not be held responsible for any technical snag or network failure during online bidding.
35. Subsequent corrigendum/addendum if required shall only be available in web site indicated above.
36. The authority reserves the right to reject any or all the bids without assigning any reason thereof.
