1. The Superintending Engineer, Rural Works Division, Kuchinda on behalf of Governor of Odisha invites Percentages Rate bids in Single Cover System for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-7 (Seven) registered with ELBO, Bhubaneswar, Odisha for execution of Civil, Electrical & P.H Works. The period of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under State Government has to register under the State PWD in appropriate class of eligibility before signing of the agreement.

2. Bid document consisting of information, plans, specification and bill of quantities of the works are available in web-site [www.tenderodisha.gov.in](http://www.tenderodisha.gov.in) and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till date of submission of Bid.

3. Availability of Tender for On-line bidding from **02.05.2026** at 11.00 AM to **13.05.2026** up to 5.00 P.M from Govt. web site [www.tenderodisha.gov.in](http://www.tenderodisha.gov.in).

4. Additional performance security (APS) is being obtained from the successful bidder when the bid amount is less than the estimated cost put to tender to the extent of exact amount of different cost (As detailed below) i.e estimated cost put to tender minus the quoted amount in shape of Term Deposit Receipt pledged in favour of Superintending Engineer, Rural Works Division, Kuchinda/Bank Guarantee in favour of the Superintending Engineer, Rural Works Division, Kuchinda from any Nationalized/ Scheduled bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by the Superintending Engineer, Rural Works Division, Kuchinda (by e-mail) to the successfully bidder otherwise the bid of the successful bidder shall be cancelled. Further proceeding for blacklisting shall be initiated against the bidder as per Amendment to Para 3.5.5 (v) of OPWD Code, Volume-I vide Works Department Office Memorandum No.173/W dated 03.01.2026.

**In view of the above, the State Govt. is pleased to fix the following rate of Additional Performance Security.**

5. Bid validity period of the Tender is for a period of 90 days from the last date of submission of Bid. Conditional bid is subject of EMD. If any bidder withdraws his Bid/Tender before the said period or makes any modification in the terms and condition of the bid the EMD, deposited at the time of submission of tender /bid shall stand forfeited.

6. Exemption of EMD to the Engineer contractor will be allowed for a maximum of three works in a financial year and the fact of awarding a work with Exemption of EMD should be entered in the Original Registration Certificate of the Engineer Contractor Engineer contractor desirous to avail the exemption of E.M.D. is required to submit an affidavit to the effect that he/she has not yet availed the facility for more than two works during the current financial year.

7. The bidder should upload all the document as per clauses of DTCN in the pdf format Non- submission of Affidavit and No Relation Certificate is liable for rejection of the Tender

8. The bidders must have to submit in technical bid through scanned mode on online the following documents like (i) Valid Contractor Registration Certificate, (ii) PAN card, (iii) valid GSTIN, (iv) affidavit regarding correctness (v) affidavit of exemption for Engg. Contractor (vi) No relation certificate etc. As per DTCN.

9. The original Affidavit should be retained by the bidder with him. The bidders have to furnish the original documents to the Superintending Engineer, Rural Works Division, Kuchinda & when required for verification of tender. The successful bidder has to submit the original Affidavit to the Superintending Engineer, Rural Works Division Kuchinda before drawal of the Agreement.

10. Date of opening of tender dated 14.05.2026 at 11.00 AM in the office of the Superintending Engineer, Rural Works Division Kuchinda. If the office happens to be closed on the aforesaid date, the date of opening will be extended to next working day at same time and venue.

**11. THE CONTRACTOR HAS TO MENTION PERCENTAGE EXCESS OR LESS OVER THE ESTIMATED COST (IN FIGURE AND WORDS)**


12. In percentage rate of tender only percentage quoted shall be considered. Percentage quoted by the contractor shall be accurately filled in figure & words, so that there is no discrepancy. If any discrepancy is found in the percentage quoted in words and figures then percentage quoted by the contractor in words shall be taken as correct if excess less is not mentioned, then the rate will be treated as percentage excess.

13. The contractor will write percentage Excess or less up to two decimal point only if he writes the percentage excess or less up to more than two decimal point, the two decimal point shall only be considered without rounding up.

14. A bidder can submit only one tender paper for a particular work, submission of more than one tender paper by a bidder for a particular tender will be liable for rejection of all such tender papers as per works Department Letter No. 4985/WWE dated 28.03 2007.

15. The tender accepting authority will verify the originals of all the scanned documents of the lowest successful bidder only within 5 days of opening of the tender. In the eventuality of failure on the part of the lowest bidder to produce the original documents, he will be debarred in future from participating in tender for 3 years and will be black listed by the competent authority. In such a situation successful L-2 bidder will be required to produce his original documents for consideration of his tender at the negotiated rate equal to L1 bidder

16. The scheduled Caste/ Scheduled Tribe / Contractors desirous to avail the facility of preference as per Govt. rule should have to furnish the required affidavit to avail price preference and enclose the copy of their registration certificate stating the fact of caste by their registration authority with the bid, failing which they will not get price preference as per above rule.
