Chief Construction Engineer, Rural Works Circle, Kendrapara-Jajpur, on behalf of **Government of Odisha** invites **Percentage rate tenders for Road Works** under (**MMSY-TRIP & Impvt. Existing RD**) through **e-procurement as per enclosed Annexure**. The bid should be submitted on-line in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) by eligible class of contractors of Government of Odisha or of equivalent class of other state Government/Railways/CPWD/MES. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before award of the work.

  - a) Estimated cost more than Rs.20.00 Crore : Super Class (of Odisha PWD) & relevant class of other licensing authorities.
  - b) Estimated cost more than Rs.6.00 Crore & upto Rs.50.00 Crore : Special Class (of Odisha PWD) & relevant class of other licensing authorities.
  - c) Estimated cost more than Rs. 1 Crore & upto Rs.20 Crore : A Class (of Odisha PWD) & relevant class of other licensing authorities
  - d) Estimated cost more than Rs. 20.00 Lakh & upto Rs.3.00 Crore : B Class (of Odisha PWD) & relevant class of other licensing authorities

Bid documents consisting of qualification information and eligibility criterion of bidders, specifications, schedule of quantities and abstract of estimate of the various classes of work is available in website [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in). **All the Bidders must have to furnished the information on work in hand in complete shape as per enclosed format (Format-II) failing which their tenders will be liable for rejection.**
8. The bid for the work shall remain open for acceptance for a period of ninety days from the last date of receipt of bids. If any Bidder / Tenderer withdraws his bid/ tender before the said period or makes any modification in the terms and conditions of the bid, the said earnest money for the work shall stand forfeited.
9. The amount put to tender is exclusive of GST. The intending bidder should offer their rates excluding GST. GST as applicable on works contract shall be paid over the work bill amount at the time of payment of each bill.
10. The bidder shall not be permitted to bid for works in the R.W. Circle responsible for award and execution of contracts in which his or his spouse's near relative (defined as first blood relations and their spouses) is posted as Divisional Accountant or as an officer in any capacity between the grades of Chief Construction Engineer and Junior Engineer (both inclusive).
11. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Deptt. of the State Govt. is allowed to work as a contractor for a period of two years after his retirement from Govt. Service, without Govt. Permission.
12. Govt. of Odisha, Works Department has been pleased to fixed the **Additional Performance Security vide office . Memorandum No.173 dt.03.01.2026**. Additional Performance Security shall be taken on an incremental basis from the selected bidder for low bid prices in the project works as under
  - i. Where the bid price is below 0% but not below 10% of the project cost put to bid, no additional performance guarantee/security percentage is required.
  - ii. Where the bid price is below 10% but not below 20% of the project cost put to bid, the additional performance guarantee/security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11%, with the additional bid performance guarantee being 0.1%, and this additional performance guarantee percentage shall be applied on the bid price.
  - iii. Where the bid price is 20% or more below the project cost put to bid, the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to 1% of the bid price, and this additional performance guarantee percentage shall be applied on the bid price.
  - iv. . The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5%, or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
  - v. The additional performance security shall be treated as part of the performance security.
  - vi. Justification for abnormally low bid shall be scrutinized by the Departmental Technical committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security (APS). An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may in such cases seek written clarifications from the Bidder, including detailed price analyses of its bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other. requirements of the bid document. If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrates its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid / Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.

The security may be taken in shape of N.S.C./Post Office Savings Bank Acct. / Post Office Time Deposit Acct. / Kisan Vikas Patra / Bank Guarantee in favour of the Divisional Officer from any Nationalized Scheduled Bank in india counter guaranteed by its local Branch at Bhubaneswar / e-Bank Guarantee executed on the National e-Governance Services Limited (Nesl) Digital Document Execution Portal towards E.M.D/Initial Security Deposit/any other security deposit from the contractor or supplier, (O.M No. 1499 dtd.01.02.2023) of Works Deptt.
