NATIONAL COMPETITIVE BIDDING THROUGH GePNIC e-Procurement Notice

Chief Construction Engineer, Rural Works Circle, Sunabeda on behalf of Government of Odisha invites PERCENTAGE (%) RATE tender for the Road works through GePNICe-procurement as per Annexure. The bid should be submitted online in the website www.tendersorissa.gov.in by eligible class of contractors of Government of Odisha or of equivalent class of other State Government/Railways/CPWD/MES having experience in construction of road works in conformity with detail tender call notice for execution of the works for drawl of agreement in percentage P1 contract forms of Government of Odisha. The bidders should have possessed compatible Digital Signature Certificate (DSC) of required class. The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before award of the work.

3. Time for completion : As mentioned in the annexure column-6
4. E.M.D. required : As mentioned in the Annexure column-4 (1% of Estimated Cost of the work to be submit online)
5. Exemption of E.M.D. : As per OPWD Codal Provision
6. Cost of tender paper : Rs.10,000/-per set(Non-refundable) only. The bidder shall transfer online the cost of tender paper/document through a process as mentioned/instructed in the DTCN.
7. Mode of submission of tender : Tender should be submitted only in <https://www.tendersodisha.gov.in>

9. The Bids will be opened Online in the O/o the Chief Construction Engineer, Rural Works Circle, Sunabeda.
10. Bid documents consisting of qualification information and eligibility criteria of bidder, specifications, the schedule of quantities and abstract of estimate of the work can be had from concerned Division office and in website www.tendersorissa.gov.in.
11. The bid for the work shall remain open for acceptance for a period of ninety (90) days from the Last date of receipt of bids. If any Bidder / Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, they will be suspended for the times specified in the tender documents (minimum 180 days with black listing).
12. The scan copy of affidavit regarding correctness and Authentication must be uploaded online.
13. The tenderer should go through the eligibility criteria of DTCN before uploading the documents through online.
14. The bidder subject to be disqualified if they have record of poor performance such as abandoning the works, not properly completing the previous contract with the organization, inordinate delays in completion of other projects, Litigation history or financial failures.
15. (i) The provisions contained in Appendix - IX, Clause - 36 of OPWD Code Vol.-II have been abolished and superseded by works department Memorandum No.173, Dated 03.01.2026 & No.632, Dated 09.01.2026.
(ii) If more than one bid is quoted (Decimals up to two numbers will be taken for all practical purpose) either at the estimated cost put to tender or less than the estimated cost put to tender, the tender accepting authority will finalize the tender through a transparent lottery system, where all the concerned bidder / their authorized representative, the concerned SE or EE of the concerned Divisions and Divisional Accounts Officer (DAO) will remain present as per office memorandum No.632 Dtd.09.01.2026 of Government of Odisha, Works Department.
(iii) If the rate quoted by SC and ST Category Contractors comes to the rate quoted by the L1 bidder (decimal up to two numbers will be taken for all practical purposes) after availing 10% price preference as per para 2 of Works Department Resolution No.27748 dated.11.10.1977, the tender shall be finalized by the tender accepting authority through a transparent lottery system along with other categories of contractors as per office memorandum No.632 Dtd.09.01.2026 of Government of Odisha, Works Department.
(iv) Additional Performance Guarantee / Security shall be obtained from the successful bidder when the bid amount is less than the estimated cost put to tender as per the provisions of Office Memorandum No.173 dt.03.01.2026 and office Memorandum No.632, Dated.09.01.2026 of Government of Odisha, Works Department.
(v) After careful consideration, Government have been pleased to make amendment to Para-3.5.19 (a) (b) of the Odisha Public Works Department Code, Volume-I with the following modification. "Security for the due fulfilment of a contract should invariably be taken. The security may be taken in shape of N.S.C./ Post Office Savings Bank Account/ Post Office Time Deposit Account/ Kisan Vikas Patra Bank Guarantee in favour of the Divisional Officer from any Nationalized Scheduled Bank in India counter guaranteed by its local Branch at Bhubaneswar/ e-Bank Guarantee executed on the National e-Governance Services Limited (NeSL) Digital Document Execution Portal/ Insurance Surety Bond issued by an Insurance Company authorized by the Insurance Regulatory and Development Authority of India (IRDAI). Such instruments shall be accepted towards Earnest Money Deposit (EMD), Initial Security Deposit/ any other security deposit from the contractor or supplier." This amendment is issued as per Office Memorandum No. 4909/W dated 12.03.2026 of the Works Department.
16. The intending bidders are to quote the rates without GST while tendering online. The GST will be paid extra on the value of work executed as applicable on works contracts at the time of payment bills.




