No.07764600022025173/W,Bhubaneswar dated 03.01.2026** of Works Department,Government of Odisha it has to be deposited in shape of Term deposit receipt/Bank Guarantee duly pledged in the favour of Superinending Engineer,R.W.Division,Koraput within 7 days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-Mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and security deposit shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder as per the clause mentioned in the DTCN.
