Chief Construction Engineer, Rural Works Circle, Berhampur on behalf of Government of Odisha invites **percentage rate tenders through e-procurement for Road Works including 05 years Post Construction maintenance under Mukhya Mantri Sadak Yojana (MMSY) for the year 2026-27.** The bid should be submitted on-line in the website www.tendersorissa.gov.in by eligible class of contractors of Government of Odisha or of equivalent class of other State Government/Railways/CPWD/MES. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Odisha, can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before award of the work.

1. Approximate Estimated Cost put to Tender : As per Annexure
2. E.M.D. : **The bidder shall transfer online the EMD @ 1% of the amount as specified for the work in the table Col No. 04 in the Annexure through a process as mentioned / instructed in the DTCN.**
3. Cost of tender paper / document : **Rs. 10,000/- per set.** (Non-refundable) only. The bidder shall transfer online the cost of tender paper / document through a process as mentioned / instructed in the DTCN.
4. Mode of Submission of tender : Tender should be submitted online in www.tendersorissa.gov.in

6. **The Bids will be opened Online in the O/O the Chief Construction Engineer, Rural Works Circle, Berhampur.**
 7. Bid documents consisting of qualification information and eligibility criteria of bidder, specifications, the schedule of quantities and abstract of estimate of the work can be had from concerned Division office and in website www.tendersorissa.gov.in. **All bidders must have to furnish the information on work in hand in complete shape as per DTCN failing which their tenders will be liable for rejection.**
 8. The bid for the work shall remain open for acceptance for a period of ninety days from the Last date of receipt of bids. If any Bidder / Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
 9. **The scan copy of affidavit regarding correctness and Authentication must be uploaded online.**
 10. The tenderer should go through the **eligibility criteria** of DTCN before uploading the documents through online.
 11. **The bidder subject to be disqualified if they have:-** record of poor performance such as abandoning the works, not properly completing the previous contract with the organization, inordinate delays in completion of other projects, Litigation history or financial failures.
 12. Govt. of Odisha, Works Department has been placed to fix the **Additional Performance Security** vide Office Memorandum No. **173 dt. 03.01.2026. Additional performance security shall be taken on an incremental basis from the selected bidder for low bid prices in the project works as under**
 - I. **Where the bid price is below 0% but not below 10% of the project cost put to bid.**

No Additional Performance guarantee/security percentage is required.
 - II. **Where the bid price is below 10% but not below 20% of the project cost put to bid.**

The Additional Performance guarantee/security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and the additional performance guarantee percentage shall be applied on the bid price.
 - III. **Where the bid price is 20% or more below of the project cost put to bid.**

The Additional Performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price.
 - IV. The Additional Performance Guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% of next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
 - V. The Additional Performance Security shall be treated as part of the Performance Security.
 - VI. Justification for abnormally low bids shall be scrutinized by the Departmental Technical Committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security (APS). An abnormally low bid is one in which the bid price. In combination with other elements of the Bid appears so low that it raises material concern as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may. In such cases, seek written clarifications from the Bidder, including detailed price analysis of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities and any other requirements of the bid document. If, after evaluating the price analysis, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.
- The Additional Performance Security place in shape of Term Deposit Receipt pledged in favour of the Divisional Officer/Bank Guarantee in favour of the Divisional Officer from any Nationalized / Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (By Email) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder.

13. The intending bidders are to quote the rates without GST while tendering online. The GST will be paid extra on the value of work executed as applicable on works contracts at the time of payment bills.

15. Authority reserves the right to reject any or all the tenders without assigning any reasons thereof.
