1. The Superintending Engineer, UI Left Canal Division No-II, Dharmagarh, Dist: Kalahandi, (Odisha) (for and on behalf of Governor of Odisha) invites **"PERCENTAGE RATE Bids" IN SINGLE COVER SYSTEM**, in electronic tendering system for the construction works detailed in the table from the class of eligible contractor in Column -06 registered with the State Government & Contractors of equivalent grades / class registered with Central Govt. / MES / Railways for execution of Road works.

2. The bid documents is available online and bids are to be submitted online through e-tendering portal [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in). The bidders would be required to register in the web site which is free of cost. For submission of bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA).

"Aspiring bidders who have not obtained the user ID and password for participating in e-tendering may obtain the same by registering in the web site: [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in). Digital Signature is mandatory to participate in the e-tendering. Bidders already possessing the digital signature issued from the authorised CAs can use the same in this tender.

The **Bill of Quantities** shall mention Quantities of each item thereto. The Contractor has to mention his "**PERCENTAGE RATES**" in figures in the prescribed format appended to the Bid document.

The Bidder/Contractor will write **PERCENTAGE RATE** up to two decimal point only. If he / she writes the **PERCENTAGE RATE** more than two decimal point, the first decimal point shall only be considered without rounding off.

3. If the office happens to be closed on the date of opening of the Bids as specified, the Bids will be opened on the next working day at the same time and venue. The procedure followed for opening of bid is specified in Guidelines. The lowest bidder will be finalized after evaluating the bids.

4. The bids for the works shall remain valid for acceptance for a period not less than **90 days** after the **DEADLINE** for bid submission.

5. Other details can be had from the bidding documents. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidders responsibility to verify the website for the latest information / corrigendum related to the bid.

6. Tender shall be uploaded in Single Cover containing both Technical Bid and Financial Bid in the standard formats prescribed in the bid documents displayed at Govt. of Odisha e-marketplace website and submitted duly filled up. The online bidders shall upload scanned clear copies of the affidavit in support of correctness/proof of the information submitted including bid security accompanied with the tender. The bidders shall **digitally sign** all statements, documents and certificates uploaded, and an affidavit regarding genuineness/authenticity of the uploaded documents shall also be submitted. **The affidavit regarding authenticity of documents uploaded by the bidders being a legal document, checking genuineness of signatures put on uploaded documents including affidavits and lease deeds is beyond the purview of the officer inviting the tender. The bidder himself shall be liable for the authenticity of the documents if challenged by any other bidder or in a court of law.**

7. The **Single Cover** containing **Technical Bid and Financial Bid** will be opened online in the office chamber of the **Superintending Engineer, UI Left Canal Division No-II, Dharmagarh, Dist: Kalahandi at 07:30 AM on Dt. 26.05.2026** in presence of the bidders/authorized representatives who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids shall be opened on the next working day at the same time and venue.

8. Bid must be accompanied with scanned copies of valid Registration Certificate. GST Registration Certificate and PAN Card failing which the bid will be rejected. Bidders desirous to avail exemption / relaxation of EMD as per prevailing rules should upload copies of necessary documents and affidavit in support of their claim along with their bid. **Bidders registered as "S.C. & S.T Contractors" desiring to avail concession(s)/ price preference as per prevailing rules should apply for the same in writing in shape of Affidavit and upload necessary document and affidavit in support of their claim along with their bid, failing which their case will not be considered for availing price preference as per the above rule. No claim in this regard after opening of the bid will be entertained.**

9. Additional performance security shall be taken on an incremental basis from the selected bidder for low prices in project works as under. As per Office Memorandum No. 07764600022025-173 BBSR dated 03.01.2026 of Works Dept. Govt. of Odisha.

- i) Where the bid price is below 0% but not below 10% of the project cost put to bid, no additional performance guarantee/ security percentage required.
- ii) Where the bid price is below 10% but not below 20% of the project cost put to bid, the additional performance guarantee/ security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and this additional performance guarantee percentage shall be applied on the bid price.
- iii) Where the bid price is 20% or more below of the project cost put to bid, the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price 20% of project cost to bid in addition to 1% of the bid price and this additional performance guarantee shall be applied on the bid price.
- iv) The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% of next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
- v) The additional performance security shall be treated as part of the performance security.
- vi) In case of abnormally low bids the Procuring Entity may in such cases, seek written clarification from the bidder about the capability to deliver the contract at his offered price. However it would not be satisfactory, the tender inviting authority may be rejected the bid proposal.

10. If the rate quoted by the SC & ST Category Contractor comes to the rate quoted by the L1 bidder (decimal up to two numbers will be taken for all practical purposes) after availing 10% price preference as per Para-2 of Works Department Resolution No. 27748 dated 11.10.1977, the tender shall be finalized by the tender accepting authority through a transparent lottery system along with other categories of contractor as per Office Memorandum No. 07764600022025-632 BBSR dated 09.01.2026 of Works Dept. Govt. of Odisha.


11. If more than one bid is quoted (decimal up to two numbers will be taken for all practical purposes) either at the estimated cost put tender or less than the estimated cost put to tender, the accepting authority will finalize the tender through a transparent lottery system, where all the concerned bidders/ their authorized representatives, the concerned SE/EE of the concerned division and Divisional Accounts Officer (DAO) will remain present. The date and time of Lottery will be communicated through online to the respective contractors if required, as per Office Memorandum No. 07764600022025-173 BBSR dated 03.01.2026 of Works Dept. Govt. of Odisha.

12. When in response to a notice calling for tenders, only a single tender is received in the first time, tender shall be cancelled without opening of bid and fresh tender be invited publicly. If single tender is received even after re-tendering, then the approval of the next higher authority should be obtained, if the tender is otherwise in order and acceptable as per O.M.No.16 dt.01.01.2015 of Works Department.

13. Engineer Contractor desirous to avail the facility of exemption of EMD is required to submit an affidavit in original to the effect that he has not availed the facility for more than three works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit falling which the tender will be rejected.

14. Conditional tender will summarily be rejected. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.




