The Superintending Engineer, UI Right Canal Division No-I, Mukhiguda, Dist: Kalahandi, on behalf of Hon'ble Governor of ODISHA invites on-line Percentage Rate bids in single cover system for the construction of work detailed in the table below from the class of contractors as mentioned in Column-5 against each work registered with the State Governments and contractors of equivalent Grade / class registered with Central Government / MES/ Railways or other govt. undertakings for execution of Civil works. All the contractors are to be registered in the State portal and must possess compatible digital signature certificate for online bidding. The bid should be submitted by eligible class of contractors Online in the Govt website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in). The bidders should have necessary portal enrolment (with own digital signature certificate). The registered bidders from outside of Odisha can also participate in this online tender process after necessary portal enrolment but, shall have to subsequently undergo registration with appropriate authority of the state Govt. within a month of acceptance of bid.

**Bidders registered themselves under CDMS portal can only participate in the bidding process after 31.12.2020 as per works Dept. Letter No. 9100, dated 17.07.2020.**

2. The cost of Tender paper (Non-refundable) will be accepted via online mode on Electronics Receipt only, through a process as mentioned in the DTCN. The bidders with pending or failure Payment status shall not be able to submit their Bid. The tender inviting authority, state procurement cell, NIC & the designated bank shall not be held responsible for such pending or failure.


4. The Bid documents consisting of plans, specification, schedule of quantities and a set of terms and conditions of the contract and other relevant documents, if any can be seen & downloaded online and Bids furnishing with scan copies of Valid Contractors Registration, Tender cost, EMD, GSTIN Registration Certificate, PAN card, Affidavit about the authenticity of the tender documents and No relation Certificate, Bill of quantities (BOQ) (In XLS Format), Special conditions & other documents if, any as per DTCN (In PDF format) should be submitted online through the e-tendering portal [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in). The above documents are mandatory along with the tender documents, otherwise his/he bid shall be declared as non-responsive and thus liable for rejection. For submission of Bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). The bidder himself/herself is liable for the authenticity of the documents if challenged by any other bidder or in the court of law.
5. The Bid documents will be available in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) from **10.00 AM of 18.05.2026 to 5.00 PM of 29.05.2026** for online viewing & bidding. Bid shall be received on or before **5.00 PM of 29.05.2026**. (Online) The Tenders will be opened in the Office of the **Superintending Engineer, U.I. Right Canal Division No. I, Mukhiguda** on dated **30.05.2026 at 11.00 AM** in the presence of the bidders/ their authorized representatives who wish to attend, after due login on to the site through their DSC. The lowest/successful bidder will be finalized after evaluating the bids. The original affidavit & other related documents should be deposited by the successful bidder before drawl of agreement for its verification at the office of the **Superintending Engineer, U.I. Right Canal Division No. I, Mukhiguda**.
6. **Single Cover (Technical/ Financial):** should be submitted with Tender cost (online), EMD (online), valid GSTIN, PAN, Contractor Registration Certificate, Affidavit, Undertaking declaration no relationship with Department officials, No Litigation Certificate, Bill of Quantities (BOQ) (in xls format), Special conditions in conformity with DTCN, if any (in pdf format) and any other document as per DTCN (in pdf format) online in [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in).

7. Additional performance security shall be taken on an incremental basis from the selected bidder for low prices in project works as under. as per Office Memorandum No. **07764600022025-173 BBSR dated 03.01.2026 of Works Dept. Govt. of Odisha.**
- i) Where the bid price is below 0% but not below 10% of the project cost put to bid, no additional performance guarantee/ security percentage required.
  - ii) Where the bid price is below 10% but not below 20% of the project cost put to bid, the additional performance guarantee/ security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and this additional performance guarantee percentage shall be applied on the bid price.
  - iii) Where the bid price is 20% or more below of the project cost put to bid , the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price 20% of project cost to bid in addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price.
  - iv) The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% of next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
  - v) The additional performance security shall be treated as part of the performance security.
  - vi) In case of abnormally low bids the Procuring Entity may in such cases, seek written clarification from the bidder about the capability to deliver the contract at his offered price. However it would not be satisfactory, the tender inviting authority may be rejected the bid proposal.
8. If the rate quoted by the SC & ST Category Contractor comes to the rate quoted by the L1 bidder (decimal up to two numbers will be taken for all practical purposes) after availing 10% price preference as per Para-2 of Works Department Resolution No. 27748 dated 11.10.1977, the tender shall be finalized by the tender accepting authority through a transparent lottery system along with other categories of contractor as per Office Memorandum No. **07764600022025-632 BBSR dated 09.01.2026 of Works Dept. Govt. of Odisha.**
9. If more than one bid is quoted (decimal up to two numbers will be taken for all practical purposes) either at the estimated cost put tender or less than the estimated cost put tut to tender, the accepting authority will finalize the tender through a transparent lottery system, where all the concerned bidders/ their authorized representatives, the concerned SE/EE of the concerned division and Divisional Accounts Officer (DAO) will remain present. **The date and time of Lottery will be communicated through online to the respective contractors if required,** as per Office Memorandum No. **07764600022025-173 BBSR dated 03.01.2026 of Works Dept. Govt. of Odisha.**
10. The single tender received in the 1st tender call shall be cancelled without opening of the bid. The acceptance of a single tender received even after re-tendering should have prior approval of next higher authority.

terms and conditions of the bid, the E.M.D deposited at the time of submission of the tender shall stands forfeited.

12. The Bidder must go through the Bid documents meticulously before uploading the tender to the web site.
13. The contractor has to quote the percentage excess or less up to two digits only after decimal point. If he quotes the percentage excess or less in more than two digits after decimal point, the first two digits after decimal point shall only be considered without rounding off.
14. In the eventually of failure on the part of lowest successful bidder to produce the original documents, he/she shall be debarred in future from participating in tender for three years and action will be initiated for black listing by the competent authority.
15. If the bidder back out from the offer before acceptance of the tender by the competent authority, the EMD & APS deposited by the bidder shall be forfeited.
16. The Bidder must provide his/her **mobile No. and e-mail ID** along with the tender documents for further correspondence required if any. Status after opening of the tenders will be displayed in online i.e. in Govt. of Odisha web site **www.tendersodisha.gov.in** & also in the Notice Board of Division Office (this office will not be held responsible for non intimation to bidder due to non submission of his/her mobile no. /e-mail id.)
17. Addendum/Corrigendum/Cancellation if any will be hoisted in the website only. Conditional tender will be summarily being rejected.
18. Bid value should be exclusive of GST and GST on works Contract, as applicable at the time of Payment shall be paid over and above the Gross amount of the Bill, as per Odisha GST Act 2017.
19. Agreement shall be drawn only after due verification of APS & ISD of the L1 bidder and if any illegitimate instruments are found, Criminal proceedings will be initiated against him/her and action will be initiated for Blacklisting through the License issuing Authority.
20. Copy of valid GSTIN shall be uploaded along with the Tender documents for considering the Tender. Non furnishing of valid GSTIN will lead to REJECTION of Bid.
