**MANNER OF SUBMISSION OF TENDER DOCUMENTS AND ITS  
ACCOMPANIMENTS**

The E-Tender document should be submitted in **Two separate Covers** as mentioned below on <https://mahatenders.gov.in>

**ENVELOPE No. 1 :-** The first envelope should submitted online (scanned copies of following documents.)

1. Online Payment Slip of Tender fee & EMD.
2. Contractor should submit company profile with particulars of firm (Partnership/Pvt. Ltd. Proprietary concern of corporation)
3. Attested copy of certificate as registered contractor with the P.W.D. Govt, of Maharashtra and state government/ central govt.
4. Attested copy of valid GSTIN registration Certificate.
5. The Contractor shall attach copy of MSME reg. certificate with NSIC certificate if applicable (Bidders claiming exemption from submission of EMD & Bid participation fee shall submit Valid NSIC certificate from same have been indicated in the certificate is valid on date of submission of the bid.)
6. IT Returns (ITR) of Last Three Years.
7. Details of work of similar type and magnitude carried out by the contractor/Bidder at any Gov/Semi Govt. Institution.

**N.B.:** in any of the documents from the compulsory documents mentioned above is not furnished in the technical bid, the tender will be treated as invalid.

**ENVELOPE No.:- 2**

The second Cover shall contain only BoQ File. In this bid, the tenderer shall submit "COMMERCIAL TENDER BID" i.e. minimum rate offered inclusive of all taxes. Tender who are not uploaded/downloaded as per the above prescribed manner will be treated as invalid.

**SUBMISSION OF TENDER :-**

Tender should by only submitted online on <https://mahatenders.gov.in>The completed Tender form must be submitted on or before Dt. **21/05/2026** up to 15.00 hrs. The tender offered after the date and time will not accepted. The tenderer should fill rates of all the items compulsory. The tenderer does not do so will be rejected.

## **OPENING OF THE TENDER :-**

Following procedure will be adopted for opening of the tender. The tenderers are at liberty to be present or authorize their representative to be present for opening of Tender Bid at the time and date specified on the Tender Form. Commercial Tender Bid of tenderers, whose documents are found as per mentioned in tender form will be opened at time and date. The tenderers commercial bid will be opened if and only if the tenderer is qualified in technical bid opening.

## **GENERAL TERMS & CONDITIONS :-**

1. All supplies should be At Agricultural Produce Market committee Warora, Dist. Chandrapur.
2. Rates that be quoted including all Taxes, transportation, except unloading labour charges and installation charges.
3. Loading and unloading of material is to be arranged by the supplier at their cost.
4. E.M.D. amount should be submitted online through Net Banking only.
5. The amount of earnest money will be refunded to the unsuccessful tenderer on deciding about the acceptance of the tender or on expiry of the validity period whichever is earlier. In case of the successful tenderer it will be refunded on this paying the initial security deposit and completing the tender documents or will be transferred towards a part of security deposit to be paid after awarding of the work. If Successful tender does not pay the security deposit in the prescribed time limit and completed the agreement bond, his earnest money deposit will be forfeited to Department.
6. After allotment of contract, contractor will have to deposit 10% security deposit against the contract cost. Fix deposit certificate/national saving certificate will not be accepted against security deposit. The successful tenderer will have to pay security Deposit within 7 days o issue of offer letter by the Union. The security deposit shall be refunded to the contractor after the successful completion of work and satisfactorily report of our Technical officer.
7. In the event of work order being placed on the successful tenderer against his offer and his failure to complete the work in accordance with the term's and conditions of this tender or his failure to replace material rejected by the committee within such time as may be stipulated. Committee shall be entitled to purchase the material and complete the work from any other sources and at such price as the committee shall be recovered from the tenderer either out of the EMD and of security Deposit or from the bills payable to the tenderer and or by way of any other legal remedies.
8. The time schedule for the works will be 60 days Contractor will have to strictly adhere to this schedule. In the event of delay in execution of works, Administrative officer and Secretary of Agricultural Produce Market Committee, Warora, Dist. Chandrapur reserves the right to impose such penalty in his sole discretion as he thinks fit.

9. Time is the essence of the contract. The work should be completed within time limit from the date of the work order issued to the contractor to commence the work. The successful contractor will have to give a schedule of various items of work to be done so that the work gets complete within the stipulated time.
10. Price variation will not be paid to the contractor.
11. Administrative officer and Secretary of Agricultural Produce Market Committee, Warora, Dist. Chandrapur reserves the right to call for break up of the contract where ever-necessary.
12. **TERMINATION OF CONTRACT** :In the event if the successful tenderer fails to comply the present terms and conditions of this contract or any part there of the Committee shall be entitled to take any one or all the Actions mentioned below.
  - a. To terminate the present contract by giving 15 days' notice in advance.
  - b. To forfeit the full amount of security Deposit or any part there of against the losses and damages which cost has incurred.
  - c. To purchase the balance quantity of required material from open market and recovered excess amount paid by the Committee.
  - d. To recover penalties and other charges as provided in the present contract.
  - e. Without prejudice to the above remedies and actions, Market Committee shall be at liberty to initiate appropriate legal actions against the contractor for the breach of contract by the contractor.
13. The successful Tenderer will have to execute an agreement on stamp paper with management within 7 days after issue of offer letter.
14. The tender submitted by the tenderer shall remain valid for a period of 60 days from the date of opening.
15. Right either to reject or accept any or all the tenders without assigning any reason is reserved by the board of Directors of Agricultural Produce Market Committee, Warora, Dist. Chandrapur.
16. Board of Directors of Agricultural Produce Market Committee, Warora, Dist. Chandrapur will be the arbitrator in case of dispute between client and tenderer his decision will be final and binding on both the side.
17. Any conditional tender will not be accepted.
18. The contractor will have to self-attest the original copy of tender paper Tech. and other conditions, according to which work is to be done. He shall also have to give a declaration to the effect that he has fully studied the tech. specifications local conditions for the works availability of labour and material and that he has quoted his rate with due consideration to all these factors in the same documents downloaded from <http://mahatenders.gov.in>
19. The Contractor shall have to execute the work as per Rules, Standards & Technical Specifications.
20. To recover from the contractor, as liquidated damages a sum equivalent to ½% of the price of the undelivered stores at the stipulated rate for each week or part there of during which the delivery of such stores may be delayed subject to maximum

limit in case of an order not exceeding Rs. One lacs in value of 5% of the stipulated price of the stores so undelivered. Such penalty is to be deducted always by the consignee from the bill of the firm.

21. To purchase elsewhere, on contractors account and contractors risk the stores so undelivered or others of similar description where other exactly complying with the particulars are in the opinion of the Board of Directors of Agricultural Produce Market Committee, Warora, Dist. Chandrapur which shall be final, not readily procurable without cancelling the contract in respect of consignment not yet due for delivery.
22. **To cancel the contract ...** In the event of action being taken on the contractor shall be liable to make good of any loss which the Government of Maharashtra may sustain by reason of higher price of the stores so purchased or otherwise howsoever.
23. The decision of the Board of Directors of Agricultural Produce Market Committee, Warora, Dist. Chandrapur shall be final as regards the acceptability of stores supplied by the contractor and the Administrative officer and Secretary of Agricultural Produce Market Committee, Warora, Dist. Chandrapur shall not be required to give any reason in writing or otherwise at any time for rejection of the stores.
