Commandant 84 Bn CRPF Old FCI Camp Chatha Jammu (J&K) 180009, for and on behalf of the President of India, invites sealed Two Bid limited tenders from approved/registered and eligible suppliers for Construction of Plinth for PF Hut Size 18x32 Ft with 5ft verandah for Control Room and Signal Centre at Tac Hq Boom Ramban J&K, as per Appendix A1 as follows:

2. All details of tender including specifications, terms and conditions and all tender documents will be available on CPPP can be downloaded by the bidders, free of cost.
3. Bids will be accepted online under two bid system (i) Technical Bid and (ii) Price Bid.
4. Intending tenderers must read the terms and conditions carefully and submit their tenders if they consider themselves eligible and are in possession of all the required documents. Only the Bids submitted online through CPPP will be accepted. All those documents which are required to be submitted offline should be SUPERSCRIBED as "Quotation for Construction of Plinth for PF Hut Size 18x32 Ft with 5ft verandah for Control Room and Signal Centre at Tac Hq Boom Ramban J&K" and sent by Speed Post/Registered Post/ Courier / By hand in favour of The Commandant 84 Bn CRPF FCI Camp Chatha Jammu J&K 180009.
5. Tenders will be opened at Hq 84 Bn CRPF Chatha Jammu J&K. Tenderers have the liberty to remain present during opening of tender. In case the date of opening of tender happens to be a closed holiday, the tenders will be opened on the next working day at the stipulated time.
6. All tender documents, attached with this invitation to tender including specifications, are sacrosanct for considering any offer as complete offer. It is, therefore, important that each page of the tender documents should be duly completed and signed and submitted with your offer.

7. The registration of the contractors should be valid on the last date of evaluation of Technical Bid. In case only the last date of evaluation of Technical Bid is extended, the registration of the contractor should be valid on the original date of evaluation of Technical Bid. In case both the last date of evaluation of Technical Bid and Price Bid are extended, the registration of contractor should be valid for original date of evaluation of Technical Bid.

8. Details required to be furnished by all bidders in Technical and Price bid are as under:

a) TECHNICAL BID :

ii) Acceptance of details of work as specified/prepared in Appendices A1 worked out by authorized SI (Civil) of CRPF and approved by competent authority.

All pages of tender documents duly completed and signed without indicating the rates quoted. Full name and status of the person signing the tender documents must be clearly mentioned.

iii) Tender cost Rs 200/, in the form of CDR/BD/DD/Fixed Deposit Receipt/Bank Guarantee from any of the nationalized / commercial banks, in an acceptable form in favour of the Commandant 84 Bn CRPF Jammu, payable at SBI Old Satwari Jammu (Branch code No 17963).

iv) Rs 5800.00 Earnest Money Deposit, if applicable.

Otherwise, the copy of any valid Govt authorized Registration/License, which specifies appropriate class of Contractor (CPWD/PWD/NBCC/NPCC/MSME or any Govt department) as necessary to execute the construction work.

v) Copy of PAN card.

vi) Copy of GST registration.

vii) Any other relevant documents which the firms wish to submit.

b) PRICE BID :

(i) The composite bid i.e. indicating rates for execution of work, details of rates, taxes, duties and discounts, if any, should be quoted by the bidder (in INR only). These details should be submitted on the letter pads of the Suppliers/Contractor, duly signed with seal.

(ii) Rates must be clearly written in figures as well as in words in INR.


(iii) There must not be any cutting or over writing.

(iv) FOR will be construction site as mentioned in the tender notice.

9. The tender document, consisting of specifications, rates, brand name ie ISI/ISO and terms and conditions of this supply to be complied and for execution of work, the cost of hiring of equipment's, cost of centering, shuttering carriage and other miscellaneous expenses should be reflected while quoting the labour charge.

11. Bidders should deposit Earnest Money Rs 5800.00 in the form of CDR/BD/DD/Fixed Deposit Receipt/Bank Guarantee from any of the nationalized/commercial banks in favour of the Commandant 84 Bn, CRPF, Jammu, Payable at SBI, Old Satwari, Jammu (Branch code No17963).
