**Note:-**

1. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. Information and Instructions for bidders posted on website shall form of bid document.
3. The bid document consisting of plans, specification, the scheduled of quantity of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website Central Public Procurement Portal for e-Procurement at <https://eprocure.gov.in/eprocure/app> or [www.dda.org.in](http://www.dda.org.in) free of cost. 4. But the bid can only be submitted after uploading the mandatory scanned documents such as unique transaction reference of RTGS/NEFT towards cost of bid document, other documents as specified.
5. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
6. The intending bidder must have valid class-II/III digital signature to submit the bid.
7. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
8. Bidder can upload documents in the form of PDF format.

- 9 The Bidders should ensure before tendering in DDA that the requisite fee has already been deposited with CRB. The bidders should also enroll on the above mentioned website before tender submission.
- 10 The Bidders will use one UTR for one work only. In case it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.
- 11 Further all updates, corrigenda, Addenda, Amendments, Time extensions, Clarifications etc., (if any) to the tender will be hosted in the above website only. There will not be any publication of the same through newspapers or any other media. Bidders should regularly visit above website to keep themselves updated.

**TECHNICAL BID:-**

The Tenderers are required to upload following documents in technical bid:-

- (i) Scanned copy of Proof of registration fees paid in Contractors Registration Board (CRB) of DDA.
- (ii) Scanned copy of Unique transaction reference of RTGS/NEFT for EMD.
- (iii) Scanned copy of Enlistment order with DDA of the Contractor.
- (iv) Scanned copy of Certificate of Registration for Goods & Service Tax (GST) with up-to-date GST return.
- (v) Scanned copy of Tender Acceptance letter (To be given on Company Letter Head.)
- (vi) Any other document specified in the tender document.
- (vii) Scanned copy of Permanent Account Number.
- (viii) Scanned copy of Performa for Additional Performance Security in the Form of FDR Deposit Declaration
- (ix) Scanned copy of registration with ESIC & EPFO.

The Tender Acceptance letter has to be given on Company Letter Head at the time of submission of Technical Bid as per Annexure VI given in NIT. Any tender found lacking with respect to the necessary information and / or documents and with the Technical bid will not be considered.

- (i) Earnest money shall be deposited through RTGS/NEFT in the account of SR. ACCOUNTS OFFICER,CAU(HORTICULTURE),DDA having ACCOUNT NO.01201110000010 with HDFC Bank, GF 01,02,03, LAXMI DEEP BUILDING, LAXMI NAGAR DISTT. CENTRE VIKAS MARG, DELHI-110090(IFSC code-HDFC0000120). The unique transaction reference of RTGS/NEFT shall have to be uploaded by the tenderer in the e-tendering system by the prescribed date. The Executive Engineer,HCD-5 will get tender cost/earnest money verified from CAU based on the unique transaction reference number against each RTGS/NEFT payment before the tenders are opened.
- (ii) A part of earnest money is acceptable in the form of bank guarantee also. Earnest Money up to Rs.20.00 lacs will have to be deposited through RTGS/NEFT mode. If the amount of E.M is more than Rs.20.00 lacs then the amount of E.M. beyond Rs.20.00 lacs can be deposited in the form of Bank Guarantee also. Such Bank guarantee is to be scanned and uploaded to the e-tendering website within the period of tender submission.
