**Criteria of eligibility for submission of tender documents.**

Percentage rate tender are invited for the work on behalf of DDA from the approved and eligible contractors registered with DDA.

**A. Building & Road 1) For works costing upto Rs. 1.30 Crores: -**

In case of Building & Road category, tenders shall be open to contractors registered with DDA only.

2) For works costing above Rs. 1.30 Crores upto Rs. 15 Crores :- a) Tenders shall be open to DDA & CPWD enlisted contractors as per their enlistment. b) The tenders shall also be open to non-DDA, non-CPWD contractors i.e., those of appropriate list of MES, BSNL Railway and State P.W.D provided they have satisfactorily completed similar nature of work as mentioned below during last 7 years ending last day of month previous to the one in which the tenders are invited:-

- i) Three similar nature of works, each of value not less than 40% of the estimated cost. or
- ii) Two similar nature of works, each of value not less than 60% of the estimated cost or
- iii) One similar nature of work value not less than 80% of the estimated cost

3) For works costing above Rs. 15 Crores upto Rs. 50 Crores :- a) Tenders shall be open to DDA & CPWD enlisted contractors in Class I as per their enlistment. b) The tenders shall also be open to DDA & CPWD enlisted contractors in Class II and those of appropriate list of MES, BSNL Railway and State P.W.D provided they have satisfactorily completed similar nature of work as mentioned below during last 7 years ending last day of month previous to the one in which the tenders are invited:-

- i) Three similar nature of works, each of value not less than 40% of the estimated cost. or
- ii) Two similar nature of works, each of value not less than 60% of the estimated cost or
- iii) One similar nature of work value not less than 80% of the estimated cost

4) For work costing above Rs. 50.00 Crores :- a) NIT approving authority may incorporate pre-qualification and post-qualification conditions as per specific requirements of the project. b) The tenders shall also be open all contractors provided they have satisfactorily completed similar nature of work as mentioned below during last 7 years ending last day of month previous to the one in which the tenders are invited:-

- i) Three similar nature of works, each of value not less than 40% of the estimated cost. or
- ii) Two similar nature of works, each of value not less than 60% of the estimated cost or
- iii) One similar nature of work value not less than 80% of the estimated cost.

Note(1):- The bidder will use one UTR for one work only. In case, it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future."

Note(2):- The intending tenderer should ensure before tendering in DDA that the requisite fee has been already deposited with CRB.

- Important terms & conditions for tenderers. Tenderers are required to go through the same before participating in the tender.
1. The unique transaction reference on RTGS against EMD shall be placed online at specified location for Tender for Electronic Time and Attendance Recording System. First cover containing "Financial bid" as well as "reference of EMD.
  2. The financial bids shall be opened online at 3:30 PM on date 12.05.2026 in the presence of a committee or their representatives by authorized bid openers. Price Bids of only those tenderers shall be opened whose financial bids qualify, at a time and place of which notice will be given. The Tenderer technically qualified will be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.
  3. The tenderer should furnish **Rs. 56,345.00/-** as Earnest Money in the form of RTGS/NEFT .The EMD amount will be retained by DDA as part of security deposit, in case tender is accepted, otherwise it will be refunded. However no interest shall be payable on the earnest money.
  4. The tender shall be submitted online in two parts, viz., financial bid and price bid.
  5. Before submission a tender, the tenderer will be deemed to have satisfied himself by actual inspection of the site and locality of the work, that all condition liable to be encountered during the execution of the works are taken into account and that the rates he enters in the tender forms are adequate and all-inclusive to accord with the all the provision of the standard/ General Condition/Clause of contract of /bid document for the completion of works to the entire satisfaction of the engineers.
  6. Tenderer will examine the various provisions of the central goods and services tax Act, 2017( CGST) /integrated goods and service Tax Act, ( IGST)/Union Territory goods and services tax act (UTGST)/respectively states goods and service tax act 2017(SGST) also as notified by Central/State Govt. and as amended from time to time and applicable taxes before bidding. Tendered will ensure that full benefit of input tax credit (ITC) likely to be availed by them is duly considered while quoting rates.
  7. The successful tenderer who is liable to be registered under CGST/IGST /UTGST/ SGST Act. Shall submit GSTIN along with the other details required under CGST/IGST /UTGST/ SGST Act. To DDA immediately after the award of work without which no payment shall be released to the contractor. The contractor shall be responsible for deposition of applicable GST to the concerned authority.
  8. Every tendered/bidder is required to be register compulsory himself under CGST/IGST/ UTGST/SGST Act.
  9. TDS under the provision GST law shall be deducted from the bills and or/payment of.
  10. Provision of GST Act. 2017 shall have the superseding effect over the all earlier taxes like VAT/WCT/Service Tax/etc. as contemplated in the Act. Accordingly the terms VAT/WCT/Service Tax/etc. appearing anywhere in the bid document may be read as the applicable tax under the GST Act. 2017.
  11. Implementation of Goods and service tax (GST) in DDA will be as per the F & E circular No.11/2017 issued by Chief Accounts Officers on dated 20.07.2017.

- i) Scanned copy of Unique transaction reference of RTGS/NEFT of Earnest Money **Rs. 56,345.00/-**.
- ii) Scanned copy of Proof of registration in Contractors Registration Board (CRB) of DDA .
- iii) Scanned copy of proof of depositing E-Tender processing fee to CRB/DDA.
- iv) Copy of enlistment order.
- v) Scanned copy of Certificate of Registration for GST and acknowledgement of up to date filed return upto previous month or previous quarter .
- vi) Scanned copy of Tender Acceptance Letter (To be given on Company Letter Head).
- vii) Copy of certificate of registration with EPFO and ESIC.
- viii) Scanned copy of undertaking on a non-judicial stamp paper of Rs. 100/- that agency is not blacklisted or debarred by any Govt./PSU or Private organization Agency/ Firm/ Person/ Tendered.

Note: -Affidavit /undertaking on a non-judicial stamp paper should not be older than one month from last date of submission of bid.
