
Tenderers are required to go through the same before participating in the tender.

1. The unique transaction reference on RTGS against EMD shall be placed online at specified location for Tender for Electronic Time and Attendance Recording System. the tender shall be submitted online.
2. The tenders shall be opened online at \_\_\_\_\_ dated \_\_\_\_\_ in the presence of a committee or their representatives by authorized tender openers. The Tenderer will be at liberty to be present either in person or through an authorized representative at the time of opening of the tender or they can view the tender opening event online at their remote end.
3. The tenderer should furnish **Rs.-----** as Earnest Money in the form of RTGS. The amount will be retained by DDA as part of security deposit, in case tender is accepted, otherwise it will be refunded. However, no interest shall be payable on the earnest money.
4. The tender shall be submitted online.
5. **The bidder shall furnished an additional performance gurantee / performance security in case of Abnormally low bids ( ALB) as per the circular number 3/2026 dated 02.03.2026 issued by CE (HQ & QAC ) ,DDA.**
