(2):- The value of executed similar works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last day of submission of bid.

For this purpose, cost of work shall mean gross value of the completed work including cost of materials supplied by the government/client but excluding those supplied free of cost. This should be certified by an officer not below the rank of Executive Engineer/Project Manager or equivalent.

Similar works shall mean "construction of road, storm water drain"
