- The tenders shall be issued to DDA enlisted contractors of appropriate class in CIVIL category. The tender shall also be issues to CPWD, MES, BSNL, Railways and other Central/State Government enlisted contractors of appropriate class subject to the condition that they have satisfactorily completed three similar nature of work each of value not less than 40% of the estimated cost or two similar works each of value not less than 60% of the estimated cost or one work of similar nature of value not less than 80% of the estimated cost in the last 7 years ending last day of the month previous to the one in which the tenders are actual value of work at simple rate of 7% per annum; calculated from the date of

completion to last date of receipt of applications for tenders.

4. The intending tenderer should ensure before tendering in DDA that the requisite e-tendering fee has been already deposited with CRB, DDA.
5. Every tenderer / bidder is required to be registered compulsorily himself under GST ACT.
6. 8. The tenderer should deposit Rs. 56,966.00 as Earnest Money through RTGS/NEFT mode in the account of Sr. A.O (CAU) Horticulture. The Earnest Money will be returned to unsuccessful bidder. Earnest Money of successful Bidder will be returned only after receiving the performance Guarantee and **Additional Performance Guarantee (if applicable)**, however no interest shall be payable on the earnest money.

10. The bidder will use one UTR for one work only. In case it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.
11. **CARE IN SUBMISSION OF TENDERS**
 - i) Before submitting a tender, the tenderer will be deemed to have satisfied himself by actual inspection of the site and locality of the works, that all conditions liable to be encountered during the execution of the works are into account and that the rates he enters in the tender forms are adequate and all inclusive to accord with the all the provisions of the Standard/ General Conditions /Clauses of Contract/bid document for the completion of works to the entire satisfaction of the Engineer.
 - ii) Every tenderer/bidder is required to be registered compulsorily himself under GST Act.

13. The intending bidder must read the terms and conditions of PWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
