The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.

Information and Instructions for bidders posted on website shall form part of bid document.

The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen from website Central Public Procurement Portal fore-Procurement at documents <https://eprocure.gov.in/eprocure/app> or www.dda.org.in in free of cost. But the bid can only be submitted after uploading the mandatory scanned documents such as unique transaction reference of RTGS/NEFT towards, EMD and other documents as specified.

Bidders registered in Contractor's Registration Board (CRB) of DDA are required to pay the e-tendering annual charges as under:-

2.	Class-II	Rs. 16,000.00 + 18% GST
3.	Class-III	Rs. 14,000.00 + 18% GST
4.	Class-IV	Rs. 10,000.00 + 18% GST
5.	Class-V	Rs. 6,000.00 + 18% GST

Online tender documents submitted by intending bidders shall be opened only of those bidders, whose Earnest Money Deposit, Tender Documents and other documents uploaded on the website by intending tenderers & downloaded are found in order.

The bidder will use one UTR for one work only. In case it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he shall be debarred from further tendering in DDA in future.

NOTE: - The bidder should ensure before tendering in DDA that the requisite fee (annually) has already been deposited with CRB. The bidder should also enroll on the above-mentioned website before tender submission.

Earnest Money and cost of tender shall be deposited through RTGS/NEFT in the account of Sr. A.O. (CAU) Dwarka, DDA having Account No. 01321110000036 with HDFC Bank, D-5, Mahavir Enclave, Palam Dabri Road, Palam, New Delhi Branch (IFSC Code HDFC0000132). The unique transaction reference of RTGS/NEFT shall have to be uploaded by the tenderer in the e-tendering system by the prescribed date. The Executive Engineer, DPD-5 will get earnest money verified from CAU based on the unique transaction reference number against each RGTS/ NEFT payment before the tenders are opened.

The Tenderers are required to furnish following documents in technical bid:-

1. Scanned copy of unique transaction reference of RTGS/NEFT/IMPS for EMD.
2. Scanned copy of Proof of Payment of E-tendering fee in CRB of DDA.
3. Scanned copy of Enlistment Order of the Contractor.
4. Scanned copy of certificate of Registration of GST.
5. Scanned copy of Tender Acceptance Letter (It is mandatory to be given on Company Letter Head).
6. Scanned copy of ESI, EPF registration.
7. Scanned copy of Cancelled banker's cheque (Optional).

Note: -Affidavit /undertaking on a non-judicial stamp paper should not be older than one month from the last date of submission of the bid.

Any tender found lacking with respect to the necessary information and /or documents and/or Earnest Money with the Technical bid will not be considered.
