1. (a) The tenders are invited from contractors registered in DDA and CPWD in the appropriate class provided they have satisfied the conditions given below.

~~(b) Eligibility conditions for Non DDA, Non CPWD contractor. The tenders shall also be opened to Non DDA, Non CPWD contractors registered with Govt. department such as BSNL, MES & Railways and State PWD of appropriate class provided they have satisfied the conditions given below.~~

**For works costing upto Rs. 1.30 Crore** in case of civil category tenders shall be issued to contractors registered with DDA only.

~~For works costing above Rs. 1.30 Crore upto 15 Crores, the tender shall be issued to DDA & CPWD enlisted contractors as per their enlistment. The tenders shall also be issued to non DDA, non CPWD contractors provided they have satisfactorily completed three similar nature of works, each of value not less than 40% of the estimated cost in the last five years or two similar nature of works, each of value not less than 60% of the estimated cost or one similar nature of work value not less than 80% of the estimated cost in the last 7 years ending last day of month previous to the one on which the tenders are invited.~~

~~For works costing above Rs. 15 crores but upto Rs. 50 crores, the tender shall be issued to DDA contractors as per their enlistment. The tender shall also be issued to non DDA contractors provided they have satisfactorily completed three similar nature of works, each of value not less than 40% of the estimated cost or two similar nature of works, each of value not less than 60% of the estimated cost or one similar nature~~

~~The Bidder who have satisfactorily completed similar works during last 7 years ending last day of the month previous to the one in which tenders are invited. For this purpose, cost of work shall mean gross value of the completed work including cost of materials supplied by the government/client but excluding those supplies free of cost. This should be certified by an officer not below the rank of Executive Engineer/Project Manager or equivalent.~~

~~Three similar completed works, each costing not less than the amount equal to 40% of the estimated cost of work put to tender.~~

~~The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to previous day of last date of submission of tenders.~~

- 1.1.1. The enlistment of the contractor should be valid on the last date of submission of tenders. In case only, the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.
- 1.1.2. The intending bidder is required to pay the e-tendering annual charges as per class of contractor plus GST @18% to CRB/DDA, at 1st Floor, Vikas Minar, ITO, New Delhi-110002 through DD/RTGS/NEFT in the account of "PAO Engineering, DDA, Vikas Minar, New Delhi" having A/C No. 1075843312 with bank CBI, Vikas Minar DDA office Building (IFSC Code CBIN0281467)
2. The intending bidder must read the terms and conditions of PWD-7 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
3. 4. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online tendering process as per details available on the website.
5. The intending bidder must have valid class-III digital signature to submit the bid.
6. Tenderer must ensure giving complete information wherever required, before submission of tender. In case, any deficiency noticed after opening of tender then no opportunity will be provided to tenderer to make good the same and the firm/contractor shall be considered ineligible. If any information furnished by the tenderer is found incorrect at a later stage, he shall be liable to be debarred from further tendering and taking works in DDA. The Department reserves the right to verify the contents/particulars furnished by the tenderer independently including carried out inspection of works completed by them.
7. (i) Earnest Money to be deposited through RTGS/NEFT in the account of Sr. A.O./CAU (NZ), DDA having A/C No. **0287111000022** with **HDFC Bank**, B-3-2 Ashok Vihar phase II ,New Delhi-110052 (**IFSC Code HDFC0000287**)&**MICR CODE 110240039**. The unique transaction reference of RTGS/NEFT shall have to be uploaded by the tenderer in the e-tendering system by the prescribed date. The Executive Engineer, NMD-1 will get earnest money verified from CAU based on the unique transaction reference number against each RTGS/NEFT payment before the tenders are opened.  
(ii) Earnest money and e-registration fee paid to be deposited through separate transactions.  
(iii) The bidder will use one UTR for one work only. In case it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.
8. Online tender documents submitted by intending bidders shall be opened only for those bidders, whose Earnest Money Deposited, proof of e-registration fee paid and other documents will be found in order.
9. The eligibility documents shall be opened first on due date and time as mentioned above. The time and date of opening of financial bid of contractors found eligible shall be communicated to them at a later date.
10. The Financial bid of tenderers who satisfied eligibility criteria shall then be opened on a specific time and date which will be intimated separately.
11. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many tenders are received satisfying the laid down criterion
