Detail Tender Terms and conditions

> ELIGIBILITY

The bidder shall provide sufficient documentary evidences to satisfy the following conditions

Pre-Qualification Criteria

- The Contractor/Bidder must be a registered contractor MJP or PWD of Maharashtra Government or A Company registered under Company's Act 1956 or 2013 or A Partnership Act firm registered under Partnership 1932 or Limited Liability Partnership registered under "The Limited Liability Partnership Act, 2008, or Proprietorship firm(s) or Valid MSME certificate
- The Contractor/Bidder must have prior work experience/Work order/Work done in similar plantation works such as **road side tree plantation or dense forest or avenue plantation or urban forests or park development/Garden for government authorities. Contractors should attach certificates of similar work done or work Orders in last 5 years as per below:**

1 (One) similar work project of 80% of the total value of estimated cost put to tender

OR

2 (Two) similar work projects of 50% of the total value of estimated cost put to tender

OR

3 (Three) similar work projects of 40% of the total value of estimated cost put to tender.

(Note Experience certificates/ Work order issued only by government departments, semi-government bodies, or public sector undertakings or urban local body or local authorities will be considered; certificates from private individuals or organizations shall not be accepted)

Bidders are required to visit the site of the plantation works. A Site Visit Certificate issued and signed by the Chief Officer, Sindkhed Raja Municipal Council must be obtained and uploaded with the tender documents in Envelope 1 (Technical Bid)

- The bidder must have sufficient qualified technical staff and resources to execute the plantation/garden development work successfully. A list of key technical personnel and their roles/responsibilities should be provided.
- The bidders must have required average CA Certified Last three-year Avg. Turnover certificate (**min. 50% of estimated tender cost**) with **UDIN number**. Supporting audited financial statements or certificates from a Chartered Accountant must be submitted along with the bid to establish compliance.
- The bidder should have required Last three year (AY) Income Tax Return.
- The bidder should have required CA Certified **Positive Net worth Certificate** Should be at least **40% of estimated project cost** in previous year.
- The firm registration must not have been **blacklisted or debarred** by any Government department or Urban Local Body (ULB) in India. An Undertaking to this effect (that the firm is not blacklisted) must be submitted on the company letterhead, signed by the authorized signatory.
- The bidder must possess a valid **GST registration and PAN** (Permanent Account Number.) Copies of the GST Registration Certificate and PAN card should be enclosed.
- The bidder must have **EPF (Employees Provident Fund) and ESIC** registration for its organization's employees. A copy of the EPF registration certificate should be provided. For the garden work the bidder should have 2 Agriculture on his pay roll should submit PF & ESC challan for 6 months as proof.
- Affidavit-A and B regarding correctness and no near relative working in Sindkhed Raja Municipal council of bid on Rs. 500/-stamp paper.
- Access of credit facility Limit (CFL) / Bank Solvency Certificate (BSC) issued by bankers minimum Rs 100 Lakhs nationalize or schedule bank (Only one of bank solvency accepted).
- Annexure as per Tender

- If required, original certificates shall be produced for verification by the tenderer and will be returned after verification.
- The application form should be signed by a power of attorney person on behalf of the Firm/Organization/ member, who is duly authorized to do so .
- If the space in the application form is insufficient for furnishing full details, such information should be supplied on a separate sheet duly signed by competent authority. Applications containing false or inadequate information are liable for rejection and SMC reserves the right to blacklist or termination those agencies.
- The firms which do not fulfill pre-qualification criteria shall not be considered for selection and award of work.- SMC reserves the right to verify any or all the documents furnished by the Tenderers with any authorities.
- Sindkehd Raja Muncpal Council (SMC) also reserves the right to cancel any or all the applications without assigning any reason thereof.

1. COST OF BIDDING

The bidder shall bear all costs associated with the preparation and submission of bid and Sindkhd Raja Muncpal Council will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

2. DOCUMENTS COMPRISING THE BID

The Bid prepared by the Bidder shall be uploaded in "Two parts Viz. Technical and Financial bids comprising the following components. Bids shall electronically submit online in the E-tender platform and the documents shall be scanned and submitted.

Envelop I - Technical:


Bidder shall submit relevant certificates to full fill the eligibility criteria prescribed in the Pre-Qualification under eligibility criteria.

(Note : The Bidder is expected to verify all instructions, forms, terms and specifications in the Tender Document. Failure to furnish all information required in the tender document will be at the Bidder's risk and may result in rejection of the bid. Bidder should submit one hard copy of all documents to Sindkhd Raja Muncpal Council within before bid opening date Envelop-I.)

Envelop II - Financial:

Financial Bid shall contain:

- The bidder should quote the price as against total tender estimate as shown in the tender document.
- Prices shall be quoted in Indian Rupees only
- In no circumstances, escalation in the prices will be entertained.
- Financial Bid uploaded with an adjustable price quotation will be treated as non-responsive and will be rejected.
- Any Bid not in accordance with above clauses of this Section will be rejected.
