Indore Development Authority (IDA) intends to carry out Development of Convention-cum-Exhibition Centre at Scheme No.172, Indore on Public Private Partnership (PPP) mode. Land admeasuring about 17.00 Ha (“Site”) in Scheme No 172 is proposed to be taken up for development. Out of the Total 17.00 Ha, 11.00 Ha of the Site (“Site for Convention-cum-Exhibition Centre” or “Site for CEC”) will be utilised for Development of Convention-cum-Exhibition Centre (“Project” or “CEC”) and balance 6.00 Ha of the Site (“Site for Commercial Development” or “Site for CD”) will be utilised for Commercial Development (“Commercial Development” or “CD”), as per the provisions of the RFP Document.

The Site for CEC will be provided to selected Developer on License/Concession for Design, Build & Finance of CEC during Construction Period as per the Minimum Development Obligations provided in the RFP Document and Operation, Maintenance & Management of the same during Concession Period as per the provisions of the RFP Document. The Site for CEC along with developed project facilities will be transferred back to IDA after the end of Concession Period. The Site for CD will be provided to selected Developer on Free-hold ownership rights for development and disposal of Plots/Built properties in CD as per the provisions of the RFP Document.

The prospective Bidder has to quote for **Annual Concession Fee** for License/Concession on 11.00 Ha, of Site for CEC for development and operations rights on CEC and **Sale Premium** for Free-hold ownership rights on 6 Ha, of Site for CD being provided to selected Developer. The sum of quoted total **Annual Concession Fee** for entire Concession Period (discounted @ of 10% per annum to arrive at net present value) and quoted **Sale Premium** shall be the bidding parameter (“**Total Bid Price**”). The prospective bidder quoting Highest Total Bid Price shall be selected as Developer
