





The **Superintending Engineer, Kendrapara (R&B) Division-I, Kendrapara** on behalf of Governor of Odisha invites **Percentage Rate bids** in **Single cover** system in **online mode** for **Electrical and Civil works** as detailed in the table, from the class of eligible contractors as mentioned in column-7(seven) registered with the State Governments and contractors of equivalent Grade/ Class Registered with Central Government/ MES/ Railways/CPWD for execution of civil works and Specialized agency having MOU with Electrical contractor having valid license issued from ELBO ( MV / HT or above Class) or vice versa for Electrical works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. In case of successful bidder who is not registered under State Government, has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work.

6. (i) Bidders have to remit their Earnest Money Deposit/ Bid security towards cost of Bid documents at Column.05 & 06 above in online mode The bidders with pending or failure payment status shall not be able to submit their bid.  
(ii) **ADDITIONAL PERFORMANCE SECURITY** shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the Additional Performance Security (APS) as tabulated below :

If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
