1. The Chief Construction Engineer, **Cuttack (R&B) Circle, Cuttack** on behalf of Governor of Odisha invites **Percentage Rate bids** in double cover system in **online mode** for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-4(four) registered with the State Governments and contractors of equivalent Grade/ Class Registered with Central Government/ Other State/ MES/ Railways/CPWD for execution of civil works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under State Government has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work as per prevalent registration norms of the state. The contractor of equivalent Grade/ Class Registered with Central Government/Other State/ MES/ Railways/CPWD will not be entertained if he is already registered with State Government of Odisha and in this case, his eligibility will be decided as per the qualifying criteria of State PWD.
2. **Each bidder shall submit one bid for one work either individually or as a proprietor or as a partner in a partnership firm or as partner in joint venture or as a company registered under Companies Act. If found to have applied / participated severally in a single work, it will be considered having a conflict of interest and all the proposals with bidders participated shall be disqualified.**
3. The bidders may submit bids for the following works.

Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opening on the next working day at the same time and venue.
