**DETAILED NOTICE INVITING TENDER**

1. Online tenders are invited under two-bid system (Technical Bid and Financial Bid) for construction of godowns on Food Corporation of India's ("FCI") land on Build, Finance & Maintain basis, at the following locations, under the Asset Monetization Policy of the Government of India:

The obligation of the tenderer would be construction of above-mentioned specified capacity of godowns as per FCI specifications given in detail in this Model Tender Form within the specified period. The successful tenderer will handover constructed godowns and will be liable for engineering maintenance of the civil structure including electrical installation, CCTV Camera and allied hardware, its maintenance for a period of 10 (ten) years ("Maintenance Term"). The capacity so constructed will be owned, managed, controlled and supervised by FCI at all times.
3. Interested and eligible tenderers are required to submit their Bids in the prescribed Tender Form strictly in accordance with the terms & conditions thereof.
4. The tender documents may be downloaded from Central Public Procurement Portal <https://eprocure.gov.in/eprocure/app>. Aspiring tenderers who have not enrolled/registered in e-procurement should enrol/register before participating through the website <https://eprocure.gov.in/eprocure/app>. The portal enrolment is free of cost. Tenderers are advised to go through instructions provided at Annexure-A regarding 'Instructions for online Bid Submission'.
5. Tenderers can access tender documents on the website, fill them with all relevant information and submit the completed tender document into electronic tender on the website <https://eprocure.gov.in/eprocure/app>. Tenders and supporting documents should be uploaded through e-procurement portal. Hard copy of the tender documents will not be accepted.
6. Bidders who are participating in more than one tender of similar works should ensure that they possess net worth not less than the combined net worth mandated in individual tenders, failing

to do so will result in disqualification of all bids of concerned bidder.
