For and on behalf of the Food Corporation of India (hereinafter called the Corporation) the General Manager (UP), Food Corporation of India, Uttar Pradesh Region, Lucknow invites tendering of limited tenders UNDER TWO BID SYSTEM from the sponsored security agencies nominated by DRZ(C) ,C/O HQRs Central Command, Lucknow Cantt-02 for engagement/deployment of supplier/contractor for security and allied services **FSD Manduadih and FSD Vyasnagar under FCI, DO Varanasi (U.P.)** for a period of one year, which shall be extendable for further period of one year at the sole discretion of FCI subject to satisfaction of services in accordance with the guidelines, terms and conditions of the Govt. of India, Ministry of Defense, Directorate General Resettlement, New Delhi/MTF.

(A) DETAILS OF SUBMISSION/OPENING OF LIMITED TENDERS

1. FCI is utilizing services of e-Procurement platform of NIC for the purpose of this tender. The tenderers who wish to participate in the e-Tender will have to register themselves on the e-Procurement platform <https://eprocure.gov.in/eprocure/app> which is free and to complete necessary formalities as prescribed by NIC.
2. The Tenderers may contact NIC with regard to technical issues relating to functioning of their e-Procurement platform or any doubts regarding online submission of Bid Document in the under mentioned Contact: **Dedicated helpline: 1800 3070 2232**
3. The Tender Documents and other detailed terms & conditions are available on the Food Corporation of India website www.fci.gov.in (for reference only) as well as at <https://eprocure.gov.in/eprocure/app> (for reference and online tendering).
2. Tender documents may be downloaded from Central Public Procurement Portal <https://eprocure.gov.in/eprocure/app>. Aspiring Bidders/Suppliers who have not enrolled/registered in e-procurement should enroll /register before participating through the website <https://eprocure.gov.in/eprocure/app>. The portal enrolment is free of cost. Bidders are advised to go through instructions provided under the head “Instructions for online Bid Submission” of this tender.
3. Tender shall be electronically submitted (on-line through internet) within the prescribed date and time as mentioned in the Tender document and e-Procurement portal. Submission of Hard copy of the Tender documents instead of electronic submission will not be accepted.
4. The tender shall be submitted in two parts, viz. Technical bid and Price bid. All supporting documents have to be uploaded along with Technical Bid and no documents are to be attached with Price Bid. Tender which do not comply with these instructions shall be summarily rejected. Further, the award of contract will be issued to the successful Tenderer through the letter of acceptance only after he/she fulfils all the requirement.
5. Any alteration, erasure so overwriting on the supporting documents should be duly initiated by authorized signatory. Tenders not accompanied by all the Schedules/ Annexure intact, and duly filled in and signed may be ignored. It should be clearly understood by the Tenderer that no opportunity shall be given to them to alter, modify or with-draw any offer at any stage after submission of the tender.
6. Non compliance of the tender documents (non-transferable) containing detailed terms and conditions and instruction/guidelines of DGR, New Delhi/MTF, or any of the information furnished by him/her is found to be incorrect or false, such agency name shall be recommended to DGR, New Delhi for blacklisting. He/ She will also be debarred from participating in any other future Tender Enquiry with FCI for a period of five years.
7. Technical bids will be opened on **27.05.2026 at 03.00 PM** online at FCI, R.O. Lucknow in the presence of the intending tenderers/their authorized representatives, who may wish to be

present or view online.

8. Tenders to remain open for acceptance up to and inclusive of sixty days from the date of opening of the Tender. The Food Corporation of India, may, at its discretion, extend this day by 30 days and such extension shall be binding on the Tenderers. If the date up to which the Tender is open for acceptance is declared to be a closed holiday/Sunday, the Tender shall be deemed to remain open for acceptance till next following working day.
9. The prospective tenderers are advised to refer to the websites for any modification to the tender Document and the tenderer shall ensure that the tender Documents submitted by them shall contain such modifications, failing which the tenders are liable to be rejected.
10. Food Corporation of India reserves the right to reject any or all the tenders and / or cancel the Tender enquiry at any stage without assigning any reason.

(B) TERMS AND CONDITIONS ELABORATED IN DGR GUIDELINES VIDE OFFICE MEMORANDUM NO. no.28(3)/2012-D(Res.-1) dated 09 July 2012, dated 16 January 2013 and 28(75)/2020-D (Res-1 dt.13 May 2021 and Corrigendum dt.23 June 2021 as well as MTF as under:-

- (i) In the eventuality of all the DGR Sponsored ESMs quoting the same rates the contract under consideration should be allotted to the senior most DGR sponsored ESM as per registration date with DGR.
- (ii) In case the principal Employer decides to cancel the tender, then the Sponsorship letter will be treated as cancelled and seniority of all the sponsored ESMs will remain unchanged.
- (iii) Agreement between the Principal Employer and the DGR Sponsored ESM should be for the period for which the DGR has sponsored the ESM/ESM Corporation. Re-Sponsorship will follow the same procedure as sponsorship.
- (iv) DGR Sponsored ESMs are not required to deposit Earnest Money Deposit (EMD). However, depending on the nature of service being provided a DGR sponsored, ESM may be asked to deposit CPG or Bank Guarantee up to a maximum limit not exceeding 10 percentage of One month's wage bill. CPG will be deducted from the ESM's Monthly service charge in installments as mutually agreed by the ESM and Principal Employer.
- (v) Successful security agency will deploy 100% ESM in following centre: - **60 Security Guards (18 Armed, 40 Unarmed and 02 Supervisors) for FSD Manduadih and FSD Vyasnagar under FCI, DO Varanasi (UP)**
- (vi) **The no. of guards may increase or decrease subject to requirement at any stage i.e. at the time of award of work & during any point of contract period.**

Further, tender may be summarily rejected in the absence of any of the documents not attached with the tender form as mentioned above from Sl no. 1 to 10. However, in case the firm is new and carrying out this business first time and ESIC, EPF and GST registration certificates are

not readily available then the self-certificate of the proprietor for ESIC, EPF and GST registration certificates stating that it will be submitted within 15 days of award of the tender is to be attached with the tender form.

After opening of technical bid, committee will examine the documents submitted by the tenderers on CPP portal and if the documents uploaded by the tenderers are found to be in order by the committee, bidders will be considered technically qualified for price bid. Proprietor of the Security agency himself or his representative (authorized by the Proprietor) will have to ensure his presence before the committee along with the original documents as mentioned above at S.No.2, 4, 5, 8 for verification. Further, documents mentioned at S. No. 6, 7, 9 & 10 would be verified online at RO Lucknow in presence of the Proprietor/representative. In case of non-verification of attached documents with the original as well as online verification, the said agency will be disqualified and committee may call next bidder/agency as per seniority order fixed by DGR, for document verification if qualified in technical bid/price bid.

(D) LIST OF DOCUMENT IS TO BE SUBMITTED WITH PRICE BID.

1. Wage structure and services charges as per DGR guidelines.

The Technical Bid will be opened first, in the Office of the Food Corporation of India, Regional Office, Lucknow at the fixed time and the date indicated above. All documents of technical bid will be verified/checked on the CPP portal by the committee. Accordingly, technically qualified or non-qualified bids will be decided and uploaded on the portal. All participant bidders will be given two days of time for raising their grievance after opening of technical bid. The PRICE BIDS of only those Tenderers shall be opened whose technical bids are found as qualified, at a time and place of which notice will be given subsequently. The Tenderers may wish to be present at the time of opening of the Technical Bid and Price Bid. The successful Agency/Tenderers will be decided on the basis of price/technical bid and advice/instructions given by DRZ(C) ,C/O HQRs Central Command, Lucknow Cantt-02 vide their sponsorship letter No. **4014/FCI/Varanasi/03 March 2026/Uttar Pradesh/9158/9821/10216/9427/res dated 03.03.2026** and as per provisions of Limited tender documents i.e. DGR guidelines issued vide office memorandum no.28(3)/2012-D(Res.-1) dated 09 July 2012 and dated 16 January 2013 and No. 28(75)/2020-D (Res)-1 dated 13 May 2021 and Corrigendum dated 23 Jun 2021. The tender which will be accepted by the Corporation shall immediately apply for labour license to the prescribed licensing authority i.e. RLC/ALC through the FCI (Principal Employer) before entering upon any work under the contract as per DGR guidelines.

The agency shall abide to provide the security services everyday as per requirement and terms and conditions of MTF/ DGR instructions shall be applicable upon them.

The Food Corporation of India reserves the right to reject any or all tenders without assigning any reasons.
