e-tendering Instructions to Bidders

1. Tender Fee & EMD Money :

a) Tender Fees As Per Column No 06 & EMD As Per column No 05 should be deposited in shape of **Online Gateway Through** any other form towards Earnest Money Deposit And Tender Fees will not be acceptable..

b) This earnest money amount shall not carry any interest whatsoever. The earnest money will be refunded in case of tenderers whose tenders are not accepted, only after completion of all formalities in respect of the accepted tender or in case of expiry of validity of offer, when specially withdrawn by the tenderer. In case of successful tenders, the earnest money will be refunded after completion of contract documents and payment of security deposit.

2. Security Deposit : Total 2%

a) 2% Initial Security Deposit to be in the form of DD in the name of E-Tender Block Development Officer Office of the Panchayat Samiti Kalamnuri, or in shape of Bank Guarantee form or in the shape of FDR of any Scheduled / Nationalized bank in the form specified, for a minimum period not less than the period specified in the tender for completion of all works including trial run period, extendible upto at least two years after satisfactory commissioning of the work by the successful tenderer. In case the Bank guarantee is submitted for initial security deposit, it will be the entire responsibility of the contractor for extension of the same till the above period.

b) Offer should be inclusive of all taxes and duties, works contract, turn over tax etc.

c) Bidder shall have to submit insurance policies as per clause 60 otherwise 1% insurance will be deducted from bill.

d) Royalty amount to be paid by the contractor to Tahsil Office, hingoli. Bill wise consumption and royalty paid statement should be furnished with each running account bill otherwise it will be deducted from bill.

3. Period of Completion

(6) Month 180 Calendar day 6 months from the date of issue of work order (including monsoon season).

4. Validity : 180 days after actual opening of complete tender.

6. Issue of Blank Tender Forms

Tender forms will have to be downloaded online as per given schedule. Tender fees once paid will not be refunded.

7. Eligibility Criteria For Prequalification:

Following shall be the criteria for eligibility.

- a) a) Registration with Zilla Parishad.
b) Registration Certificate of GST.
c) Last year ITR clearance
d) PAN Card

8. Last Date of Submission of Tender Forms

All the tender activities will be carried out on-line only. Contractors has to complete online tender download and bid preparation stages before submission of tender. Contractors can only modify his offer during bid preparation time only. Contractors cannot change or modify these bids once the bid submission period is over.

9. Manner of Submission of Tender and its accompaniments :

The tender shall be submitted ONLINE only.

A) Envelope No.1 (Technical)

The first envelope as Envelope No.1 shall contain the following documents :

1. Scan Copy Of Receipt of Online Gateway DD tender fee
2. Scan Copy Of Receipt of Online Gateway tender EMD
3. Certificate of registration in appropriate class with ZP Registered
4. Copy of PAN Card
5. Last 3 Year ITR (2022-23, 2023-24, 2024-25)
6. GST
7. All mandatory Document For technical Bid purpose.
8. All above documents should be enclosed in Envelope No.1.& Submitted All Documents Hard Copy In Panchayat Samiti Kalamnuri Office Before Bid submission end date & Time. If these documents are not Submitted In Given Time, Envelope No.2 will not be opened.

B) Envelope No.2 (Financial)

The second Envelope No.2 The tenderer should quote his offer on BoQ of the tender as percentage of estimated rates at the appropriate place on tender documents, to be

submitted only in Envelope No.2. He should not quote his offer anywhere else directly or indirectly in Envelope No.1. The Contractor shall quote for the work as per details given in the main tender

C) Submission of Tender :

All the tender activities will be carried out on-line only. Contractors has to complete online tender download and Bid preparation stages before submission of tender. Contractors can only modify his offer during bid submission time only. Contractors cannot change or modify these bids once the bid submission period is over.

D) Performance Security.

If tenderer coat his offer up to 10% below of estimated cost of work then he should pay 1% performance security. If tenderer coat his offer more than 10% below of estimated cost then he should pay additional performance security on that estimated cost on prorated basis in addition to 1%

Example:-

1) 1% - 10% below rate = 1%

2) 14% below rate

Up to 10% - 1%

14% - 10% - 4%

Total - 5%

10. Opening of Tenders :

The tenders will be opened online as per given schedule, in the office of **Panchayat Samiti Kalamnuri Dist.Hingoli** if possible, in presence of intending bidders or their authorized representatives, who choose to remain present. Following procedure will be adopted for opening of tenders.

Envelope No.1

First of all, Envelope No.1 of the tender will be opened to verify its contents as per requirements. If the various documents contained in this envelope do not meet the requirements of the **Panchayat Samiti Kalamnuri Dist.Hingoli**, a note will be recorded accordingly by the tender opening authority, and the said tenderers Envelope No.2 will not be considered for further action, but the same will be recorded.

Envelope No.2

After opening of Envelope No.1, if contents of Envelope No.1 are found to be acceptable to, then only this Envelope No.2 shall be opened immediately. The tendered rates in Schedule "B" (BoQ) as percentage above / below the estimated cost put to tender shall then be read out.

11. No Tender with arbitration clause will be considered.

12. Conditional Tender will be summarily rejected.

13. Right to modify the Tender Documents :

The right is reserved to revise or to amend the contract documents prior to the date of bid preparation of tender or the receipt of the tender or the extend the date said above such revisions, amendments or extension if any shall be communicated to all concerned in the form of corrigendum or by notice in the press as may be considered suitable.

14. Acceptance of Tender :

Right to reject any or all tenders without assigning any reasons thereof is reserved by the competent authority **Block Development Officer Class - I, Panchayat Samiti Kalamnuri Dist.Hingoli** whose decision will be final and legally binding on the tenderers.
