2. **Eligibility Criteria for submission of bid documents:**

- a. Intending bidder should not be a joint venture (Copy of relevant documents clearly establishing the status of bidder to be uploaded in Cover-1).

For Civil Works (Prime Bidders)

b. Experience of having successfully completed similar work individually costing not less than as stated below during the last 7 years ending the previous day of the last date of submission of bids.

(i) Three similar works, each of value not less than 40% of the estimated cost, (Rs. 1,98,69,600.00 for each work)

OR

(ii) Two similar works, each of value not less than 60% of the estimated cost, (Rs. 2,98,04,400.00 for each work)

OR

(iii) One similar works of value not less than 80% of the estimated cost, (Rs. 3,97,39,200.00 for each work)

Completion certificate issued by Competent Authority will only be considered. Competent Authority means officer of not below the Rank of Executive Engineer/ Equivalent would be acceptable.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of receipt of applications for this tender. (Copy of work completion certificate to be uploaded as proof of eligibility criteria in Cover-1)

c. Similar work means: - Construction of LGSF (Light Gauge Steel framed) Buildings.

3. **Turnover:** The Average Annual Turnover CA Certificate, preferably with UDIN, should be at least 50% of the estimated cost during the immediate last 3 consecutive Financial Years (2022-23, 2023-24, 2024-25), balance sheet, duly audited by a Chartered Accountant. (Scanned copy of Certificate from CA, preferably with UDIN Number to be uploaded). The year in which no turnover is shown would also be considered for working out the average.

6. **No exemption in tender fee and EMD shall be applicable for firms registered under MSE/NSIC/Udyog Aadhaar. Therefore, all the bidders are required to submit the EMD and Tender fee as mentioned in the Tender documents.**
