3. As the bids are to be submitted online and required to be encrypted (by their user Public-key) and digitally signed, the bidders are advised to obtain Digital Signature Certificate (DSC) from suitable vendors or from any authorized agency at the earliest.

5. **Terms and Conditions:-**

The e-tender documents shall be uploaded online in two (02) covers:-

- (i) Cover-1: Shall contain scanned copies of “eligibility information” i.e. copy of Certificate of registration from food safety administration for supply of above Dry Ration items, Firm Registration Certificate, PAN Card, Aadhar Card, Experience Certificate of previous three years, supply of same/similar category items, Copy of Income Tax Return of previous three years (Assessment year 2023-24, 2024-25 & 2025-26), Food and drug license, food safety certificate, duly signed tender form by the tenderer and firm GST registration certificate Address proof, (Scanned copies to be uploaded).
- (ii) Earnest Money Deposit/Bid security in the shape of National saving certificate, demand draft or fixed deposit, duly pledged in favour of **Commandant TPT Bn, ITBP payable at SBI- AFS Chandigarh (Bank Code No. -1495)**

- (iii) Copy of valid registration certificate with NSIC/DGS&D if any.
- (iv) Cover-2: Shall contain "Financial Bid" on the prescribed form.
- (v) Cover-2 shall contain BOQ (Bill of quantity) where firm will quote his offer with all taxes for the store.
6. The tender of the firms who fail to fulfill the eligibility information will be summarily rejected.
7. The Tenderer, who fail to submit of local/ manufacture brand will be summarily rejected.
8. **Tender of the firms who fail to fulfill the Technical specification (QRs) will be summarily rejected.**
9. **The firms should be submitted all samples of ration items before opening of the Tender, If samples doesn't submitted by the firms and it will be summarily rejected. Unsealed Bidder sample submitted by bidder will be summarily ignored by technical evaluation committee. Whose samples are found to be fully in conformity with the sealed samples as well as other parameters of the specifications duly examined/tested will be accepted.**
10. The firms will submit the original document in respect of Earnest Money deposit at TPT Bn, ITBP, P.O.- Airport, Chandigarh (U.T.) on **18-05-2026 up to 1030 hrs.**
11. The negotiation/clarification, if any will be taken from the successful firm only in respect of error and omission, technical aspects and in no case on financial bid.
12. If opening day is a holiday, the tender shall be opened on next working day at the same time.
13. **Instructions for e-tendering:-**
- i) Only e-offers submitted online through e-procurement portal will be considered.
 - ii) The Bidders should keep checking the website for any addenda/corrigendum to the Notice/Bidding documents till the date of online submission of bids and the bidder should incorporate the same in his bid documents.
 - iii) Bids once submitted online cannot be resubmitted or withdrawn.
 - iv) Conditional Bids and the Bids not meeting the qualifying criteria on the date of receipt of bids shall be summarily rejected.
 - v) To participate in bidding process, Bidders need to obtain Digital Certificate as per Information Technology Act-2000, to participate in online bidding. The certificate will be required for digitally signing the Bid. Bidders can get above mentioned Digital Certificate from NIC or any approved authorized agency. Firms in possession of valid Digital Certificates need not to procure new Digital Certificate they can use the same in this tender.
 - vi) The Bidders have to submit their bids online in electronic format. No proposal will be accepted in physical form.
 - vii) Bids will be opened online as per time schedule mentioned in table in Para-04.
 - viii) Before submission of online bids, bidders must ensure that scanned copy of all the necessary documents have been attached with bid.
 - ix) The department will not be responsible for delay in online submission due to any reasons.
 - x) All the required information for bid must be filled and submit online.
 - xi) Bidders should get ready with the scanned copies of cost of documents, EMD & other documents as specified in the tender documents.
 - xii) The details of cost of documents, EMD specified in the tender documents should be the same as submitted online (scanned copies) otherwise tender will summarily be rejected.
 - xiii) The firm should register itself on website (<http://eprocure.gov.in/eprocure/app>) and obtain user ID, password before bidding.

- xiv) Entire tender process will be carried out online through above mentioned website.
- xv) Firms are advised to procure e-token/Digital Signing Certificate from suitable vendors or from any authorized agency.
