Commandant (Engr), SHQ(DBRG), ITBP on behalf of the President of India invites online **Percentage rate tender** from approved and eligible firms/contractors of CPWD, MES, Railway, BRO, State PWD, MSME and BSNL registered under Building construction category in appropriate class for the following work :-

1. The enlistment of the contractors should be valid on the last date of submission of tenders. In case, the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.
2. The intending bidder must read the terms and conditions of **Tender form** carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
3. Information and Instructions for bidders posted on website shall form of bid document.

4. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website **www.itbp.gov.in & www.eprocure.gov.in**
5. The tender can only be submitted after uploading the mandatory scanned documents as per list given below.
  - i) Self attested copy of Enlistment Order of the Contractor in CPWD, MES, Railway, State PWD, BRO & BSNL in appropriate class (Civil/composite).
  - ii) List of Self attested copy of work experience certificate related to completed work only (as per criteria given on page 3 para 2(a) of tender form).
  - iii) Tender form duly signed by the firm. **If Tender form is not uploaded on e-tendering website within due period of time then technical bid of that firm will not be accepted and it will not be placed under shortfall.**
  - iv) Self attested copy of G.S.T Registration and PAN Card / TAN No
6. In addition to documents mentioned above under para 5 following documents will also to be submitted.
  - i) Self-attested copy of EPF and ESIC registration or exemption notice as applicable or affidavit of proof of applying these. (can be submitted within 15 days from the date of issue of letter of acceptance)
  - ii) Scanned self-attested copy of EMD.
  - iii) Solvency Certificate of minimum amount equal to 40% of estimated cost put to tender.
  - iv) Certificate of Financial Turnover duly audited by CA Certificate of Financial Turnover duly audited by CA to be uploaded as per format in Form "A"
7. Earnest Money of **Rs. 7,30,451/-** in form of Banker's Cheque or demand draft or Fixed Deposit receipt of any scheduled bank drawn in favour of The DIG, SHQ (DBRG), ITB Police, Mohanbari, Dibrugarh. The bidder will ensure physical submission of original EMD either in the office of Dy. Commandant (Engr), SHQ (Dibrugarh) or any nearest formation of ITBP within period of bid submission time. Receipt of EMD obtained from the concerned Engineering Branch of any formation of ITBP, to be scanned and uploaded to the e-tendering website at the time of bid submission. (Format of receipt placed at **page 40** of Tender form). EMD exemption (i.e MSME certificate etc) is not allowed. **If EMD is not deposited in physical form by due date and time 26.05.2026 at 1600 Hrs. in mentioned address or any office/formation of ITBP, technical bid of that firm will not be accepted and it will not be placed under shortfall.**
8. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.
9. The intending bidder must have valid class-III digital signature to submit the bid.
10. Bidder should not have past track of delaying works.

11. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
12. Contractor can upload documents in the form of JPG format and PDF format.
13. Contractor must ensure to quote percentage. The column meant for quoting percentage in figures appears in pink color and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no percentage is quoted by the tenderer, percentage of such item shall be treated as "0" (ZERO). However, if tenderer quotes Nil percentage against in percentage rate tender or does not quote any percentage above/ below on the lowest amount of the tender or any section/sub head in percentage rate tenders, the tender shall be treated as invalid and will not be considered as lowest tender.
14. The required documents meeting the criteria to qualify as "approved and eligible" contractors of CPWD, MES, Railway, State PWD & Telecom/BSNL Dept etc. along with other documents as mentioned under Para "List of Documents to be scanned and uploaded by the agency and **hard copies received subsequently shall be checked first, while opening the bid.** The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.
15. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
16. As per policy of Govt. of India to encourage "Make In India" and promote manufacturing and production of goods and services of India. The provisions vide order no. P-45021/22017/PP (B.E-ii) Dated 29.05.2017 on the subject "Public Procurement (Preference to Make In India), order 2017-revsion" shall be fully applicable.
