- Manual bids will not be accepted.
- For submission of E-bids. Bidders are required to get themselves registered with E-procure.gov.in website along with class-III Digital Signature Certificates issued by CCA under IT act-2003.
- Tender forms are issued free of cost to NSIC registered firms.
- All firms required to deposit Earnest money duly verified by respective bank/branch as mentioned above along with tender forms.
- All firms to deposit original copy of EMD duly verified by respective bank/branch at Main gate, 26th Bn ITB Police, as mentioned above. All firms who are not registered as MSEs as defined in Procurement Policy issued by MSME for the subject stores for which the offer is being invited, are required to deposit EARNEST MONEY equivalent to the amount as mentioned in the tender schedule. If any firm not have registration for all items, then EMD is compulsory.
- Bidders are requested to upload copy of AOC (Award of contract/CRAC) & experience certificate for each supply completing during last three year
- Average annual financial turn over during last three years should be 40 to 80% of estimated amount duly authenticated by CA.
- All the bidders are requested to submit all loose sample (in 250gms packet) to the Commandant, 26th BN, I.T.B.Police, Baddowal Distt- Ludhiana. Punjab During the EMD submission date and due receipt with date and time specified be taken.

- ix. **Undertaking –regarding compliance with FSS Act and regulation**
- x. **The bidding firm has to give a self-certificate to the effect that it has not been blacklisted/debarred/suspended by any Central Ministry/Department, State Govt., PSUs or Banks etc. The certificate has to be scanned and uploaded along with the tender documents. If it is subsequently established or found that the bidding firm has given any false information or facts or has suppressed facts and manipulated the documents etc, the earnest money deposit or the performance security deposit, as the case may be, will be forfeited and no excuse what so ever will be entertained thereof.**
- xi. **Other relevant documents as Tender documents & annexure and which the firm wishes to submits**
11. The intending bidder must read the terms and conditions of Tender form carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
12. The successful tenderers will be required to furnish Security Deposit @ 05% of contract value duly verified by respective bank/branch. Within 07 days of award of contract/Acceptance Letter.
13. Information and Instructions for bidders posted on website shall be the part of bid document.
14. The tender can only be submitted after deposition of original EMD in the office of Commandant, 26thBn, I.T.B.Police, Baddowal Distt-Ludhiana. Punjab within the period of bid submission and uploading the mandatory scanned documents such as Insurance Surety Bonds, Demand Draft/Fixed Deposit Receipt /Pay Order/ Banker's Cheque/Bank Guarantee of any scheduled Bank towards EMD in the favor of Commandant 26thBn I.T.B.Police mentioned in NIT
15. Bidder should not have past track record of delaying works.
16. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.
17. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion
