

1. Qualification Criteria:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

i.	Technical Criteria:
a.	The Bidder must be Manufacturer/Authorized Dealer of of P.H and Sanitary Materials. Certificate of incorporation / ISO certification / Factory license shall be submitted as a documentary proof.
b.	The Bidder must indicate the Make/ Manufacturer /country of origin for items quoted in the Technical Unpriced Bid in the tender document as per the make list provide for the tender
c.	The Bidder must comply to the BOQ and materials shall be supply as per technical specification as stipulated in the tender document. Bidder to submit Technical No-Deviation Certificate. In case of any deviation with the technical specification bidder to submit technical deviation sheet along with the Bid documents.
d.	<ul style="list-style-type: none"> • Bidder must submit successfully executed Purchase Orders for supply of of P.H and Sanitary Materials to any Govt/Private organisation in last 5 years (ending last day of month before the one in which applications is invited). Purchase Order Copy should be either of the following: • At least one purchase order value not less than INR 12.00 lakhs. <li style="text-align: center;">OR • At least of two purchase order of value not less than INR 7 lakhs. <li style="text-align: center;">OR • At least of three purchase order of value not less than INR 6.0 lakhs.
Note	<p>Notes for Technical Criteria:</p> <ul style="list-style-type: none"> • The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above and should have completed the supply.(Relevant order copies along with proof of execution (such as copy of invoice, LR/Shipping documents/ Waybill). • The date for eligibility of documents shall be considered/counted the date of initial Techno Commercial Bid Opening date shall be first scheduled Techno Commercial Bid Opening Date. <p>Guarantee/ Warrantee shall be 12 months from the date of use or 18 months from the date of supply whichever is earlier.</p>
ii.	<ul style="list-style-type: none"> • Financial criteria
a.	Average annual financial turnover during last three years (i.e., 2023-24, 2024-25 and 2025-26) should be INR 16.00 Lakh or more. Average Annual Turnover Certificate issued by Certified Chartered Accountant must be submitted along with the Techno-commercial Bid along with Audited Balance Sheet and profit & Loss A/C.

b.	<p>The Bidder must accept the terms and condition if the tender especially the terms and condition mentioned Buyer's ATC. Bidder to submit Commercial No-Deviation Certificate.</p> <p>In case of any deviation with the commercial terms and condition bidder to submit commercial deviation sheet along with the Bid documents.</p>
c.	<p>The Bidder must confirm for submission of Earnest Money Deposit (EMD) amount stipulated in the Tender Document or must submit copy of Udyam/ MSME/ NSIC Registration Certificate (if Bidder has claimed for exemption for submission of EMD amount) INR 28,000/-</p>
d.	<p>The bidder must not have been blacklisted or debarred in last five years to participate in tendering of similar supply earlier by any Govt./ Public Sector Utility/ IPP/ CP (Self-declaration to be submitted on Bidder's letter head, same to submitted along with Technical Bid Unpriced Bid).</p>
Note	<p>Notwithstanding anything stated above, OPGC reserves the right to assess the capability and capacity of the Bidder to perform the contract, Limit the restriction or accept the bids of reputed (Branded) manufactures/vendors should the circumstances warrant such an assessment in the overall interest of OPGC.</p> <ul style="list-style-type: none"> • For all qualification criteria all supporting documents to be provided. Owner reserves the right to obtain necessary documents and to assess the qualification of the Bidder, after submission of bid, as deemed necessary by Owner to establish bidder's qualification. • Any Public Sector Undertaking (PSU) willing to participate in the Tender shall be exempted from Qualification Criteria based on the documentary proof.
