Inland Waterways Authority of India (IWAI) invites Online tenders in two cover system (**Cover I - Technical bid** and **Cover II - Financial Bid**) from reputed & experienced contractors for the work of **Supply & Deployment of Security Personnel for Safety and Security at R.O., Terminal, Patna and S.O., Bhagalpur during June’2026 to March’2027”**.

1. Bids shall be submitted online only at CPP website <https://eprocure.gov.in/eprocure/app>. Manual bids shall not be accepted and liable to be rejected.
2. The Scanned copy of cost of tender document and earnest money as asked in this tender document is to be uploaded while submitting the bid on or before opening date/time as mentioned in critical date sheet.

Against the submitted bid. NEFT/RTG S attached/submitted for tender fee shall be non refundable.

4. However, Micro, Small and Medium Enterprises, (MSME)/NISC or are registered with central purchase organization Ministry or Department or startups as recognized by department of Industrial policy & promotion (DIPP) shall be exempted from depositing EMD & Tender fee as per rule.

5. The tenderer shall have to meet the following pre-qualification criteria:

- i) The tenderer shall be registered with the relevant department for supply/deployment of Armed /Unarmed Security Guards and having registration certificate with GST, ESI, EPF and the scan copy of the same may be submitted by the tender along with online bid.
- ii) Minimum Average Turn Over during last three years ending 31st March (**i.e. 2022-23, 2023-24 and 2024-25**) should be at least **3 times (i.e. Rs. 202.00 Lakhs)** of the estimated cost of the contract. Experience of having successfully completed similar works/supply of security Guards(armed & unarmed) during last 7(seven) years ending last day of month previous to the one in which this tender is invited should be either of following:
 - (a) Three similar works costing not less than 40% of the estimated cost; **or**
 - (b) Two similar works costing not less than 60% of the estimated cost; **or**
 - (c) One similar work completed not less than 80% of the estimated cost
- iii) Latest bank solvency certificate (issued in favour of Inland Waterways Authority of India, Patna) for the minimum amount as specified in the tender (not older than 6 months).
- iv) The tenderer shall agree to the terms & conditions of the tender and return the tender document duly signed and stamped in each page for agreeing the same.

- a) The tenderer shall submit required Earnest Money Deposit through RTGS/NEFT. Any/all submissions made without the earnest money and/or after the date mentioned hereinafter in clause 6 shall be deemed to be rejected.
- b) Similar work shall mean work for supply/deployment of Armed /Unarmed Security Guards for safety and security in any other Govt. organization.
- c) The firm should not have incurred loss for more than 2 years during preceding three years ending 31st March, 2025.
- d) The firm should have valid Permanent Account Number (PAN).
- e) The Private security Agency shall have register under Private Security Agency Regulation Act of concern State Govt.

Parties fulfilling the above indicative eligibility criteria can download tender document from the “<https://eprocure.gov.in/eprocure/app>” and IWAI’s website “www.iwai.nic.in”. Bidders submitting the downloaded version of tender document is required to submit Rs 5900/- (Rupees Five thousand Nine Hundred only) i.e. an amount equal to the cost of tender document along with tender in the form of NEFT/ NEFT/RTGS made in favour of ‘IWAI fund’ payable at Patna at any nationalized/ schedule bank.

A signed declaration stating that no alteration has been made in any form in the downloaded tender document is to be enclosed with the tender by the bidder for downloaded tenders. Site can be inspected on all the working days during office hours. IWAI reserves the right to reject any or all the tender without assigning any reason thereof.

6. The firm may quote for work of indicated above and completed bids as per terms & Conditions mentioned in the tender document should be online submission through <https://eprocure.gov.in/eprocure/app> upto **22.05.2026 at 15.00 hrs** and it will be opened on **23.05.2026 at 15.30 hrs**.

8. For special attention

- All tenderers are cautioned that tenders containing any deviation whatsoever from the terms and conditions, specifications as contained in the tender documents are liable to be rejected as non-responsive.
- The tender shall have to be submitted bid online in two bid format, the first part i.e. "Technical bid" should contain the scanned copy of entire tender document duly signed in all places, details of work schedule, and earnest money deposit only but not the price bid. Second part i.e. "Financial bid" shall contain only the rates of the item of work as in schedule A this price bid (BOQ for "Supply & Deployment of Security Personnel for Safety and Security at R.O., Terminal, Patna and S.O., Bhagalpur as per format provided along with this online tender. The bid shall be submitted in online through <https://eprocure.gov.in/eprocure/app>.

9. Earnest Money Deposit (EMD) and tender cost must accompany each tender and tender not accompanied by the EMD and tender cost shall be rejected as NON- RESPONSIVE. The EMD and tender cost for an amount as specified above shall be submitted in the technical bid. **However, Micro, Small and Medium Enterprises, (MSME)/NISC or are registered with central purchase organization Ministry or Department or startups as recognized by department of Industrial policy & promotion (DIPP) shall be exempted from depositing EMD & Tender fee as per rule.**

10. Opening of e-tenders & Evaluation

- (a) Tenders will be opened online by the Tender Evaluation Committee at IWAI, Gaighat, PO-Gulzarbagh, Patna at **15:30 hrs** on **23.05.2026** in the presence of representative of the tenders who choose to remain present.
- (b) After the online opening of the tenders, the first part i.e. Technical bid will be evaluated by the Tender Evaluation Committee (TEC) as constituted by the Authority. The second part i.e. Price bid will be opened online by the same TEC only for those tenderers who become technically qualified after the evaluation of technical bid on a suitable date.
- (c) In case of multiple L1, procedure prescribed under Manual for Procurement of Non-Consultancy Services shall be followed for award of the work.
- (d) Least Cost Selection (LCS) shall be the method for selection of Bidder.

11. TENDER VALIDITY PERIOD

The tender shall remain valid for a period not less than 120 days after the date of opening of financial bid.

Tenderer must read “Information & Instruction for Tenders” and be satisfied himself in respect to scope and the situation of works or any issue as related to the work as considered necessary before the submission of the tenders.

12. The authority shall have the right to reject any or all the tenders and will not be bound to accept the lowest or any other offer.
13. IWAI reserves the right to accept or reject any or all tenders without assigning any reason and no correspondence shall be entertained in this regard.
