GENERAL TERMS AND CONDITIONS FOR SUBMISSION OF TENDER

1. The tenderer should upload their bid in the prescribed enclosed Performa only in two parts i.e., Part-I (Technical & Commercial Part) and Part-II (Price Part) through e-tender portal www.jharkhandtenders.gov.in and Bidder shall deposit tender fee & EMD fee through online mode as per rules of e-tendering portal.

Note: - The bids will be received through electronic tendering mode only. Therefore, No bidder should submit hard copy of part-I & price part in any case, if found submitted, their bid against the NIT will be rejected.

2. Uploaded documents (which is duly signed seal/stamp) of the bidders may be verified with the original before at any time. The bidders have to provide the originals to the concerned authority whenever asked for. If any mismatches between uploaded documents & original documents may be found, their candidature may be cancelled, earnest money may be forfeited and they may be debarred/ blacklisted for participating in any tender under JUSNL and the undersigned has reserved the right to take necessary decision in favour or rest other bidders for onward action.
3. Bidders are requested to upload good quality scanned bid; uploaded bid should be easily readable to everyone. Poor quality scanned bid may cause rejection.
4. Department will not be responsible for any problem during uploading the tender through electronic tendering mode before scheduled date and time.
5. At any stage, if it is found that bidder have submitted false document for the purpose of qualifying in the tender, action as per Law will be taken and the pending payment, Security amount of the bidder will be forfeited by the Nigam at any stage.
6. The undersigned may extend the due date of opening of Part - I with intimation to all tenderers through e- tender portal www.jharkhandtenders.gov.in. The Price Part (Part-II) of those tenderers whose offers are found technically and commercially responsive will be opened later on through electronic mode only. The exact date & time will be intimated to the successful tenderers. **No offers/ tenders will be accepted after due date and time.**
7. Before submission of the tender the tenderers should carefully go through the contents of the tender document and make themselves fully acquainted with the stipulations made therein. In case of any confusion, tenderer may have clarifications from the tendering authority in writing. Verbal clarification shall have no binding on the tendering authority.
8. **Each page of the tender document shall be signed by the Tenderer and no overwriting shall be done. Every cutting should be properly initialed.**
9. The desirous tenderers may download tender documents including terms and conditions, B.O.Q. and technical specification from the e-tender portal www.jharkhandtenders.gov.in. No tenders will be accepted/ considered without tender fee.
 - (a) **Technical Part shall consist of the following: -**
 - (i) Offer Letter
 - (ii) Tenderer's credentials & Proof of all qualifying requirements of the Tender.
 - (iii) Proof for Earnest Money (Copy of online receipt/UTR/Reference number).
 - (iv) Deviation statement, if any.
 - (b) **Price Bid (in provided excel format only) shall consist of the following:**

Price for each and every item must be quoted in provided excel sheet only. No price bid will be accepted in hard copy.
10. **Earnest money: -**
 - a) Tender (Part - I) must be accompanied with earnest money as specified in the NIT unless exempted from such deposit, failing which the tender will be rejected.

- b) The earnest money should be deposited in online mode on e-tender portal www.jharkhandtenders.gov.in and reference be given on the cover of the tender.
- c) Cheque/ Fixed Deposit receipt/ Money Order or and saving certificate etc. are not acceptable towards deposit of earnest money and tenders with above will be considered without earnest money.
- d) Earnest money deposited by firms against any other tender of the Nigam/ or of this office will not be considered as earnest money for the present tender under any circumstances.
- e) No earnest money will be accepted after opening of the tender.
- f) As per GOJ guidelines, the EMD deposited by the all bidders will be refunded directly to their respective account after completion of tender process.
- g) The earnest money will be liable to be forfeited on revocation of tender before the validity of the quotations expire or on refusal enter into a contract after the award is made to the tenderer or deliberately giving wrong information/ whose credentials/ documents in his/their tenders and thereby creates(s) circumstances for acceptance of his/ their tender.
- h) The earnest money shall remain deposited with **Manager (F&A), Transmission Zone-VII, Dhanbad** for validity period of the offer. The earnest money of unsuccessful bidders will be returned to them after award of the contract.
- i) It should be clearly understood that in the event of the tenderers failing to accept and execute the telegraphic and detailed orders, if it is placed within the validity period of the offer, then the full amount of earnest money will be forfeited and the Nigam's decision in this respect will be final and binding on the tenderer.

11. EARNEST MONEY DEPOSIT (EMD): -

- i. The earnest money will be forfeited on revocation of tender before expiry of validity of the tender or on refusal to enter into the contract agreement after the award is made by JUSNL to the bidder.
- ii. EMD for the successful bidder will be refunded after submission of security deposit as per rules of e- tendering.

A. EXEMPTION FOR DEPOSIT OF COST OF TENDER FEE/EARNEST MONEY: -

- i. Tender Fee/Earnest money Deposit (EMD) for NSIC/MSEs of Jharkhand will be exempted but firm have to upload relevant NSIC/MESs certificate with their bid.
- ii. NSIC/MSEs are required depositing only 10% of security Deposit (SD).
- iii. Non-MSE units of Jharkhand, fulfilling eligibility criteria as envisaged in Para-11 (B) (i to viii), will get 50% concession in EMD only.

B. EXEMPTION CRITERIA: -

Tenderers who are availing benefit of exemption, under following categories, have to submit certificate related to exemption as documentary evidence for its validity on the date of submission of tender/period of delivery failing which tenders will be rejected: -

- i. The manufacturing or Service unit is located within the state of Jharkhand.
- ii. The Head Office or Corporate Office of such registered unit/ company/ enterprise is within the territorial jurisdiction of Jharkhand.
- iii. MSE is registered with the Directorate of Industries/ District Industries Centre, Khadi and Village Industries Board, Directorate of Handloom, sericulture and Handicraft of Jharkhand Govt., Industrial Area Development Authorities and national small industries corporation Ltd. Or any other body specified by Directorate of Industries, Jharkhand Govt. from time to time and other industrial units/ enterprises which have submitted IEM and been issued Date of Production (DOP) certificate by GM, DIC/MD, Industrial Area Development Authorities/ Director, Industries, GoJ.
- iv. The MSE/ other enterprise and unit must be registered under Jharkhand VAT Act 2005 or CST Act/ GST.
- v. The MSE/ other enterprises and unit must have encouraged local people in employment.
- vi. The MSE/ other enterprise and unit must have complied with all statutory and legal formalities of concerned regulators/ Act.
- vii. The MSE unit availing preferential treatment will give an undertaking with respect to (i) to (vi) above including a categorical statement that the product/ services being supplied to Govt. Deptt. Or its agencies have been manufactured/ created by the unit

located in Jharkhand only, giving details of batch no./ date or any other identifiable tag (GSI etc.) as per prevalent established practice.

- viii. Firms registered with NSIC under single point registration scheme for manufacture of the item, provided that certificate must be valid on the date of tender and during the period of delivery.

Note: - Any request for recovery from outstanding bills for earnest money against any tender will not under any circumstances be entertained. Tender submitted with earnest in shape of cheque, Government Securities or in any form other than those specified above shall not be considered. Bond of any form is not acceptable.

- 12. Price:** - The price quoted should be firm and final till execution of the contract and price must be quoted only in the Nigam's prescribed Performa. Arithmetical errors will be rectified on the following basis. If there is discrepancy between unit price and the total price i.e. obtained by multiplying the unit price and quantity, the unit price shall prevail and total price shall be corrected. If the bidder does not accept the correction of errors, his bid will be rejected. If there is a discrepancy between words and figures, the amount in words shall prevail.

In case the unit rate of an item is not quoted but the total price is indicated, the same shall be taken to arrive at the computed price. The computed price arrived at, as above, shall be considered for the purpose of award also.

If there is a discrepancy between the quantity specified by JUSNL in the bidding document and that indicated by the bidder in his bid, the former shall be taken to arrive at the computed price on pro-rata basis. If the bidder does not accept the correction of errors as worked out by above methodology, its bid will be rejected.

- **Bidder must quote rate as indicated in prescribed price format. (in provided excel format only)**
- **Price part is liable to be rejected for any column/ row left blank or filled incomplete/ vague in price format.**

- 13. Statutory Price Variation:** - The order is subject to statutory price variation. Any deviation of taxes & duties or imposition of any fresh taxes & duties during the contractual period shall be applicable. Work will be complete as details in the Tender documents of the NIT.
- 14. Inspection of Site:** Before quoting the rate, bidders are advised to visit the work site and get satisfied with scope of work for which rates are to be quoted. Bidder may consult to Work in-charge for any clarification regarding scope of work.
- 15. Scope of Work:** - As mentioned in price part schedule.
- 16. Work Period:** 01/06/2026 to 31/03/2027.
- 17. Estimated Cost:** - Rs. 16,88,044.00 only including all taxes.
- 18. Work In-charge:** - Manager, TSD, Chandankyari will be Work in-charge and Sr. Manager, Transmission Division, Dhanbad will be the overall In-charge of the work.
- 19. Payment:** - Bill shall be generated by agency and submitted to Manager (Tech.), Transmission Sub-Division Chandankyari. 95% Payment will be made against submission of bill in triplicate duly verified by concerned work-in-charge and counter signed by overall In-charge along with requisite documents and compliance of labour law. Department will make payment to the bidders subject to availability of fund from Nigam headquarter and no interest will be paid for delay in payment because of unavailability of fund. Bill should be submitted as per GST format clearly mentioning GSTIN of agency HSN/SAC code bill no. & Date.
- 20. Paying authority:** - Manager (F&A), Transmission Circle, Dhanbad.
- 21. Security deposit:** - The successful bidder shall have to deposit total security deposit @ 10 % of order value as performance guarantee in which initial security money @ 5 % of the order value before executing the agreement and balance 5 % of security money will be deducted from R/A bills/Final bill. Total Security deposit @10% will be refunded after Six month from successful completion of work, after issue of successful completion certificate from Work in-charge & Overall in-charge. The Initial security deposited will be accepted in Demand Draft (DD) only.

- 22. Additional Security:** - In case the tenders quoted below 10% of the amount mentioned in bill of quantity, provision of additional performance security will be applicable in accordance to the provisions mentioned in Para-2 (i) of Sanklap no. 2146 (S) dated - 09.09.2020 of Road construction department, Ranchi, Jharkhand.
- 23. Agreement:** - The firm or his legally authorized representative having authorization will have to execute an agreement with the ordering authority within 15 days of issue of work order / LOI. The agreement will have to be prepared in prescribed format of JUSNL (Form F-2) as per order and Initial Security Deposit (ISD) will have to be furnished well before execution of agreement failing which order may be cancelled.
- 24. Penalty:** - In case of failure to do the work within the scope of work described and as per instructions of Work-in-charge and Overall-in-Charge, penalty @ ½ % per week maximum of 10 % of the ordered value will be charged.
- 25. Taxes:** All statutory taxes as applicable shall be deducted from each of the bill of contractor.
- 26. Violation of Term & Conditions of Tender:** All terms and conditions of tender shall form a part of the contract. If contractor fails to execute the work up to entire satisfaction of Overall- In-Charge as per terms & conditions of tender, then the contract agreement can be terminated after one-month prior notice and security money shall be forfeited.
- 27. Subletting:** The successful bidder will have to execute the work directly. No subletting will be allowed.
- 28. Guarantee:** - The agency shall have to take the guarantee of the good moral character of man power supplied to the satisfaction of Work-in charge. If any misconduct found against any of supplied manpower, he/she should be replaced on recommendation of Overall in-charge.
- 29. Accommodation:** - No accommodation will be provided by J.U.S.N.L either to the proprietors or to their authorized representatives including their workmen. However, they have to maintain Co-ordination with the Work in- charge and they shall have to intimate the addresses for communications if any with the work in-charge with name of contact persons and telephone numbers.
- 30. Leave for manpower:** - The contractor has to allow leave to the supplied manpower as per provisions of labour laws in consultation with Work in- Charge. In absence of any manpower on a particular day, it may suitably compensate through available manpower.
- 31. Minimum Wage Guarantee:** - The contractor shall strictly ensure that the minimum wages as stipulated by Govt. of Jharkhand from time to time is paid to their workmen. Any increase in minimum wages during the period of contract, will have to be paid to their workmen without any claim on JUSNL. If the contractor fails to comply with guarantee of minimum wages, then the agreement is liable to be terminated and Security money may be forfeited.
- 32. Labour Laws:** - The bidder has to follow the guidelines laid under the labour law workmen compensation. In the event of any accident / casualty to the employees of contractor, the compensation payable to the employees is to be borne by the contractor and JUSNL will not be responsible in any way.
- 33. Statutory Compliances:** - All the liabilities related to manpower supplied directly / indirectly to JUSNL will be sole responsibility of the bidder. The adherence of other statutory expenses like EPF, ESIC, workmen compensation, any increase in minimum wages, bonus, etc. shall be the sole responsibility of the bidder.
- 34. Tools & Tackles:** - All necessary tools and tackles, dress code etc. as required shall have to be arranged by the agency at site.
- 35. Safety Measures:** - The contractor shall observe all the safety measures. Safety appliance has to be arranged by the contractor at his own cost. Any compensation payable to the contractor's employee in the event of accident or causality has to borne by the contractor himself and JUSNL will not be responsible on this account in any way. In case of any damage due to negligence mishandling and mal operation by the staff of contractor, the damage would be made good by the contractor at his / own cost. In case of non-compliance, proportionate deduction will be made from the bills of the contractor. During the execution of work, the worker /supervisor must be accompanied with all safety measures (Helmet, safety shoes, belts etc.).
- 36. Accident:** - In case of any accident to any of persons under their(bidder) employment or any outsiders

at the time of carrying out the work or during transportation of Man, T& P, Materials etc., the Nigam will not bear any responsibility on any account what so ever. However, the firm (bidder) may take out insurance at their own cost i.e., firm (bidder) will bear full responsibility.

37. Obligation of the Firm: -

- a) The agency will arrange required nos. of different categories of manpower for the successful execution of work and the deployment has to be reported to Overall in -charge of the work.
- b) Minor alteration/correction in the scope of work under the concerned NIT may be done in the interest of the work or as per site/work requirement.
- c) Contractors will have to replace/remove if any person employed by him for the allotted job whom Overall in-charge finds to incompetent/inefficient/bad behavior whatsoever.

38. The Nigam reserves the right to reject the lowest or any of the tender either in whole or in part without assigning any reason.

39. Transportation: - The transportation of men and material will be responsibility of the Contractor.

40. Right to amend specification: - JUSNL reserves the right to revise /amend/cancel the tender specifications and other conditions without assigning any reason thereof. Notice published in the press about such revision amendment and postponement shall be deemed to be sufficient notice.

41. Validity: - The tender should be kept valid for acceptance at least for a period of **180 (one hundred eighty) days** from the date of opening of Part-I of the tender.

42. RIGHT OF JHARKHAND URJA SANCHARAN NIGAM LIMITED TO DEAL WITH TENDERS: -

- a) Jharkhand Urja Sancharan Nigam Limited reserves the right to accept tender in whole or in part or reject any tender or all tenders without assigning any reasons thereof.
- b) The authority for the acceptance of the tender will rest with the Jharkhand Urja Sancharan Nigam Limited. It shall not be obligatory on the said authority to accept the lowest tender or any other tender and no tenderer shall demand any explanation for the cause of rejection of his / their tender.
- c) If the tenderer deliberately gives wrong information / credentials / documents in his / their tenders and thereby creates circumstances for acceptance of his / their tender, JUSNL reserves the right to reject such tender at any stage, and shall suspend the Business for three years.

43. Dispute: - Any dispute arising out of this tender, the decision of the General Manager, Transmission Zone-VII, Dhanbad shall be final & binding.

44. Jurisdiction of Court: Any dispute between the Contractor and JUSNL shall be settled in the competent court at Dhanbad, Jharkhand only.

45. Cancellation of Work Order: - General Manager, Transmission Zone-VII, Dhanbad, JUSNL reserves the right to cancel whole or part of the awarded contract founding defaulter for delay in execution of work or nonstandard quality of work.

46. Labour Law Compliance: - Overall in-charge of the work will ensure before verification of bill that all labour has been paid and relevant labour laws have been fully complied.

47. Acknowledgement: - Every order/ correspondence shall be duly acknowledged by the contractor. The signature in affidavit/B.O.Q. submitted/acknowledgement will be treated as specimen signature.

OTHER TENDER CONDITIONS

The following conditions are to be strictly fulfilled by the firm while submitting their tenders: -

1. Tenders not accompanied by the prescribed tender fee (non-refundable) and earnest money will be rejected outright.
2. Tenderer has to accept the penalty clause as per tender otherwise tender will be considered as invalid.
3. In case of authorization to sign the tender documents on behalf of the firm an authority letter with details of identification of the signatory should be enclosed with the tender.
4. The offers which are not kept valid for acceptance, for at least 180 days from the date of the opening part-I of the tenders will be rejected.
5. The bidder is expected to go through all instructions, forms, terms, specifications, and other information in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the bidder's risk and may result in rejection of its bid.
6. JUSNL reserves the right to extend the last date and time for uploading of filled in techno-commercial and price bid part.
7. If the last date of uploading of tender papers and date of opening of tender happens to be a holiday, the tender will be received and opened on the very next working day, time and venue being same as that indicated against original date of opening.
