3. The bid can be submitted in electronic format on the website "<http://mahatenders.gov.in>" from 12.00 hours on 19.05.2026 The deadline for submission of bid is up to 05.00 hours on Dt.02.06.2026
4. **Tender Form Fee and Earnest Money (EMD) both payments must be paid online. Bidders are requested to use SBI Internet Banking or Other Internet Banking in State Bank MOPS. Bidder should pay both payments by using only concern site e.g.<http://mahatenders.gov.in>. Other payment mode shall not be accepted.**
5. **Bid Shall be treated as 'invalid' if scanned copies as mentioned in (4) above are not submitted online.**
6. Technical Bids will be opened online on 03.06.2026 at 05.00 hours on website "<http://mahatenders.gov.in>" in the office of the **Sarpanch Village Panchayat Ujalaiwadi Tal-Karveer, Dist-Kolhapur.**

 8. **Security Deposit to be submitted at the time of agreement is 2.00% of contract price and balance 2.00% will be deducted from running bill.**
 9. **The guidelines to download the tender document and online submission of bids and procedure of tender opening can be downloaded from website "<http://mahatenders.gov.in>".**
 10. **Time allowed for completion of each work is 09 months and defect liability period 12 months from the date of completion of work.**
 11. **Tender form fee & Earnest money which is 1% of the amount put to tender shall be only in online Internet Banking mentioned as per clause-4. In any other form like cash or cheque /D.D. will not be accepted.**
 12. **The amount of earnest money will be forfeited in case of successful contractor does not pay the amount of initial security deposit within the time specified as stipulated by the Executive Engineer and complete the contract documents. In all other cases earnest money will be refundable.**
 13. **Examination of drawing and site conditions - The tenderer shall in his own interest carefully examine the drawing conditions of contract specifications etc. He shall also inspect the site and shall acquaint himself about the climate, physical and all other conditions prevailing at site, the nature, magnitude, special features, practicability of the works, all existing and required means of communications and access to site, availability of housing and other facilities, the availability of labor and material, labor camp site, stores and go downs etc. He shall obtain all necessary information as to the risks, contingencies and other circumstances which may effect and influence the tender. No claims on any of the above or any other factors will be entertained by the Government, should there be any discrepancy, doubt or obscurity as to the meaning of any of the tender documents, or as to the instructions to be observed by him. He shall set forth in writing such discrepancy or doubt or obscurity and submit the same to the Executive Engineer.**
 14. **The tender submitted by the renderer shall remain valid for a period of 120 days from the date opening of tenders. Also see Para 2 of General Rules etc. of the contract form.**

15. The contractor (s) whose tender is accepted is required to note that no foreign exchange will be released by the Department.
16. Tenders, which do not fulfill all or any of the conditions or are incomplete in any respect are liable to summary rejection.
17. Right to reject any or all tenders without assigning reasons there for is reserved. The acceptance of the tender lies with the **Sarpanch Village Panchayat Ujalaiwadi Tal-Karveer, Dist-Kolhapur**.
18. This notice inviting tender shall form part of the tender agreement.

The successful Tenderize will be required to produce to the satisfaction of the specified concerned authority a valid and concurrent license issued in his favor under the provisions of the Contract Labor (Regular and Abolition) Act, 1970 before starting the work. Failure to do so, acceptance of the tender shall be liable to be withdrawn and security deposit forfeited.
