The Project Director Public Works Department, (PWD)O/o Office of the Project Director ,KRFB Project Director for and on behalf of the Governor of Kerala invites online bids for the work detailed below from the Registered Bidders of Kerala PWD/Central PWD/Other Central or State Government Departments/State or Central Public Sector Undertakings etc.who have successfully completed at least one similar work costing more than 40% (Forty percentage) of the estimated cost of the work within the last five years. A certificate to this effect from the agreement executing authority of the completed similar work shall invariably be submitted along with the tender documents failing which the tenders will not be accepted. The certificate should contain the details such as name of work, agreement number, date of start and completion as per agreement, completed amount of work etc.

4	Brief Description of Work	<p>The original work was terminated at the risk and cost. The original work was prepared for the Improvements of road from Kallupalam to Kollam Beach and then to Mayyanad via Eravlpuram. Out of this, the road works upto DGBM was laid for a length of 7.5km. From Kallupalam (Ch:0/000) to Kachikadav (3/780) the road was unattended. Hence this portion is included in the balance estimate. Also, the BC layer is proposed over the entire length of the project road in the balance estimate. Also, during the Joint inspection, ED, KIIFB issued directions to include a cross drain at Mayyanad-Chanthamukk junction, (ch:11/040) and leading drain towards the outlet at Railway drain incorporating the road work of that stretch. Also, directions were issued to include some cross drains and other leading drains at waterlogging areas near Vellappilmukk as per the site conditions found during the joint inspection with MLA.</p> <p>In the revised balance estimate, all improvements to carriageway from ch:0/000 to ch:2/100 and ch:2/100 to ch:3/780(unattended portion in the original contract), BC on DGBM laid surfaces, cement concrete paver blocks on waterlogging vulnerable areas, formation of drainage and footpath works, construction of retaining wall using gabion structure from ch:2/797 to ch:3/780, and 700m DR masonry wall also added in the Beach Road- Kondayath Palam stretch, where widening proposed in the banks of Kollam Thodu, traffic safety works etc as balance quantity from the original estimate, are included. Price Bid shall only be submitted through online. Details regarding remittance of Bid Submission Fee and Bid Security, Bid preparation and submission are mentioned in the bid document.

The bids shall be opened online on 01-04-2026 at 11:00 at the office of the O/o Office of the Project Director, KRFB Project Director in the presence of the Bidders /their authorized representatives who wish to attend at the above address. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place.

More details can be had from the Office of the Project Director, Public Works Department (Public Works Department) O/o Office of the Project Director, KRFB Project Director during working hours.

All other existing conditions related to bidding in force in the Kerala Public Works Department will be applicable in this tender also unless expressly defined in the bidding document. The Tender Inviting Authority/Employer shall not be responsible for any failure, malfunction or breakdown of the electronic system while downloading or uploading the documents by the Bidder during the e-procurement process. Details required for e-payment (Details of bank account having core banking facility and email address of the bidder) shall be furnished along with the tender. Tenders not accompanied by these details will be rejected. All subsequent Government orders connected to tenders and any revision in the rates of taxes would also be applicable to this tender.

Bonus will be paid to the bidder at the rate of 1% of the estimated PAC, subjected to a maximum of Rs.5 lakhs (Five lakhs) in case of works which exceed TS power of Superintending Engineer and also if and only if the work is completed within 85% of the original time of completion (TOC) specified in the TS estimate which is calculated as per the guidelines issued by the Chief Engineer of each wing.
