**Subject:** Providing services for Comprehensive Operation and Maintenance of Storm water Pumping station at Gazdarbandh in K/W Ward for 7 years.

The BRIHANMUMBAI MUNICIPAL CORPORATION (BMC) invites e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firms, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013 , registered with the Brihanmumbai Municipal Corporation (BMC) under category Mechanical /Electrical, Class 'A' (as per new registration rules, 2016) (excluding those who are black listed or against whom FIR has been filed as per circular no. Dir/ES&P/1078/MC dt.30/11/18). The contractors/firms registered in equivalent or superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed to participate in bidding subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm in BMC within three months' time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and a penalty of 0.1% of contract cost or Rs. 10,000/- whichever is more will be recovered / deducted from the contractor's payment / bill by executing department.

Bidding Process will comprise of THREE stages.

The application form can be downloaded from e-procurement system of Government of Maharashtra (Maha tenders) (<https://mahatenders.gov.in>). The tender fee of Rs. 30,250 /-+18% GST as mentioned in header data shall be paid online and follow guidelines as per Circular no. CA/FRG/09 dt 04.10.2024. Tender fee is non refundable. The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process of Government of Maharashtra (Maha tenders) (<https://mahatenders.gov.in>) Interested bidders should have valid Class III digital signature certificate (DSC) obtained from any licensed certifying authority.
