### **E-TENDER NOTICE**

**Subject: The work of replacement of non repairable /missing CI/DI non standard circular covers with MS covers provided on storm water drain manholes as per sizes at sites in A to G/north wards.**

The Brihanmumbai Municipal Corporation (BMC) invites e-tender on item rate basis to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered with the Brihanmumbai Municipal Corporation, (BMC) under category Mechanical /Electrical , **Class 'A' as per new registration rules, 2016 (excluding those who are blacklisted or against whom FIR has been filed)** or those having equivalent or more work experience from the contractors/firms registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three month's time period from the award of contract, failing which there EMD (bid security) will be forfeited and a penalty amount equal to Registration Fee will be recovered/ deducted from the contractors payment/bill by the executing department. Bidding Process will comprise of THREE stages.

# **SECTION 2**

# **ELIGIBILITY CRITERIA**

**A) Technical Capability:**

a) The tenderer(s) in their own name should have satisfactorily completed the work of similar nature in any Municipal Corporation /Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)

1) Three similar completed works each of value not less than the value equal to Rs. 5,96,016/-

Or

2) Two similar completed works each of value not less than the value equal to Rs. 7,45,020/-

Or

3) One similar completed work of value not less than the value equal to Rs.11,92,031/-

The value of Completed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

The Bidder shall submit the certificate of satisfactory completion of work from the user Department of BMC / Semi Govt. / Govt. / Public sector organization failing which their offer shall be treated as non-responsive and their Packet 'C' shall not be opened.

**2. Financial Capacity**

Achieved an average annual financial turnover as certified by 'Chartered Accountant' equal to Rs. 8,94,023/-in last three (3) financial years immediately preceding the Financial Year in which bids are invited. The bidder shall submit the copy of certificate showing turnover certified by Chartered Accountant. The audited balance sheet and profit & loss account statement shall also be submitted.

Municipal Commissioner of Greater Mumbai reserves right to accept any bid and annul the bidding process and/or reject all the bids at any time prior to award of the contract without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for the Employer's action.

The work experience should be of "Working Directly" and possess relevant experience as per the details given under experience criteria. "Working directly" implies, working as a Contractor OR Sub-Contractor under above authorities who is the Principal Owner of the work.

Note: The cost of work completed within one year prior to the original date of bid opening shall not be considered for any weight age. The weight age shall be considered for work completed prior to one year of original date of bid opening on annual basis AND no weight age shall be given for part of the year.

**C) Similar Experience:**

For assessing the technical capacity of Regular, Routine and Maintenance works; similar

work shall mean, the completed the completed work of “**fabrication and fixing of M.S. manhole covers/M.S. water entrance gratings at site**” in BMC/Semi Govt./ Govt./ Public sector organization. **(Performance Certificate from user shall be uploaded.)**

**B) Bid Capacity: (Not Applicable for this tender)**

The bid capacity of the prospective bidders will be calculated as under: Assessed Available Bid Capacity =  $(A * N * 2 - B)$

Where,

A = Maximum value of Civil Engineering works executed in any one year (year means Financial year) during the last five years (updated to the price level of the Financial year in which bids are received at a rate of 10% per year) taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of the Project/Works, excluding monsoon period, for which these bids are being invited. (E.g. 7 months = 7/12 year) For every intervening monsoon 0.33 shall be added to N.

B = Value of existing commitments (only allotted works) on the last date of submission of bids as per bidding document and on-going works to be completed during the period of completion of the Project/Works for which these bids are being invited.

Note: The statement showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be attached along with certificates duly signed by the Engineer-in Charge, not below the rank of an Executive Engineer or equivalent.

Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:

- Made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
- Record for poor performance such as abandoning the works, not properly completing the contract, inordinate delays in failures etc.
