**Subject: Construction of compound wall along with MS fencing and allied work to safeguard Veravali High level reservoir premises in K/E ward under AE WW (Maint.) WS south –II.**

The Brihanmumbai Municipal Corporation (BMC) invites online e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies act 2013, the contractors registered with the Brihanmumbai Municipal Corporation (BMC) in “**Class – II and above in Civil as per new registration policy 2016**” and from the contractors/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months' time period from the award of contract, and shall establish office in Mumbai Metropolitan Region otherwise their Bid Security i.e. **E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty**. Bidding Process will comprise of THREE stages.

The bidder has to fill in online format and upload information regarding Tender Online.
