The application form can be downloaded from MAHATENDER portal (<https://mahatenders.gov.in>) on payment of Rs.3,300/- +18% GST. The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.

i) To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of Account Officer (FAR), 3rd floor, Municipal Headquarter.

ii) Followed by login ID and password to be obtained from MAHATENDER portal.

iii) For e-Tendering registration, enrolment for digital signature certificates and user manual, please refer to respective links provided in MAHATENDER portal. Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed by controller of certifying authorities namely, Safes crypt, IDRBT, National informatics center, TCS, CUSTOMS, MTNL, GNFC and e- Mudhra CA.
