Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, Contractor" shall mean an Individual or a Hindu Undivided Family or a Registered Partnership Firm or a Joint Stock Company or a Registered Co-operative Society or a Government, Semi-Govt. Undertaking engaged for the execution of the works for MCGM other than mere supply of goods or articles to MCGM and shall include authorized sub-contractor/s, legal representatives of such Individual or Persons comprising such Firm or Unincorporated Company or Successors of such Firm or Company as the case may be and permitted assignees of such Individual or Firm or Company. Bidding Process will comprise of Single stages.

The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.

i) To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of Account Officer (FAR), 3rd floor, Municipal Headquarter.

ii) Followed by SRM login ID and password to be obtained from Central Purchase Department (CPD), Office at Byculla, Bakariadda, Mumbai

iii) For e-Tendering registration, enrolment for digital signature certificates and user manual, please refer to respective links provided in 'Tenders' tab. Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed by controller of certifying authorities namely, Safes crypt, IDRBT, National informatics center, TCS, CUSTOMS, MTNL, GNFC and e- Mudhra CA.
