

- 5 Bidder should have valid registration either in MPMKVVCL (Civil) or MPPWD (Civil).
- 6 GST Rules of Govt. of India will be applicable as per Company's Circular No. MD/MK/CFO/TAX/GST/937 Dt. 15.06.2017 No. MD/MK/CFO/TAX/GST/1141 Dt. 23.06.2017.
- 7 Insurance will be applicable as per clause -31 under special condition of contract of tender document.
- 8 Arbitration proceedings shall be conducted in accordance with M.P. Madhyastham Abhikaran Adhinyam Act 1983.

- 9 Bidder should have to submit Completion/Performance/experience Certificate for the work of similar nature executed in a last three financial years either of these as mention below :-
- If only one work is executed, the Value of One work should be more than 70% Cost of Tender value or If two works are executed, the Value of each should be more than 40% Cost of tender value or If three works are executed the Value of each, should be more than 30% Cost of tender value.
 - By company circular no. 783 dt. 24.09.2021 the Performance guarantee will be released after 2 years Completion of work, Security deposit will be released after maintenance period of Two years.
 - The additional performance Guarantee (Security Deposit) for the bids quoted below 10% of SOR will be Deposited as per Company Circular MD/MK/Civil/2098 Dt. 13.06.2023.
- 10 Contractor has to submit certificate that no one in his relation or family member working in the MPMKVVCL organization.
- 11 Bidder should have to submit average annual turnover equal to the Cost of tender value for three financial years in last 03 years certified by C.A. or ITR for the last three years should have to be submitted.
- 12 The bidder should be registered with ESIC & EPF organization.
- 13 If the bidder is having four or more than four work orders of civil works of MPMKVVCL and not performing well, he/she will not be Entertained & their bids will not be opened.
- 14 As per instruction of corporate office, bidder should have to buy insurance policy under workmanCompensations Act 1923 before starting the work, otherwise bill, security deposit will be withhold.


